2. The Final paper (**not exceeding 7000 words**) should reach latest by, **31<sup>th</sup> December, 2019** in Soft Copy.

3. The citation should strictly conform to the rules in **The Bluebook: A Uniform System of Citation (20th edition)**.

No T.A and D.A. will not be provided to the Participants/ Presenters.


