

CIRCULAR

1. As per direction of the Competent Authority, a meeting was held on 07-08-2023 in the Seminar Hall of the Registrar Office for discussing the issue of stray dogs in the University as per Animal Act.
2. The problems/issues of Stray dogs of the University were discussed in the details as per Animal Act and followings suggestions/ decisions taken in the meeting have been approved by the Competent Authority of the University:-
 - i. Stray dogs of the University Campus should be sterilized / vaccinated by the MCD, Najafgarh Zone as per Animal Act. In this regard, necessary action will be taken by the MCD as per Animal Act, Sh. Sunil Kumar, Assistant Registrar will coordinate with MCD, Officials/Officers for completing the process of Sterilization / Vaccination. Rabies camp will be organized in the University Campus as intimated by the Dy. Director (Veterinary Services) Najafgarh, MCD
 - ii. Feeding spot in the University Campus have been identified as under:
 - a) Near STP/Horticulture Area
 - b) Behind Hostels
 - c) Near Staff Quarter Type- IIIHording should be fixed at designated spots.
 - iii. No sweets should be fed to dogs to avoid diseases as advised by the Dy. Director (Veterinary Services), Najafgarh Zone, MCD.
 - iv. A loose red bandage of good quality should be tied around the neck of dogs that have not been sterilized / vaccinated and after sterilizing/vaccinating, loose green bandage with good quality should be tied around the neck of dogs. In this regard, necessary action will be taken by Sh. Sunil Kumar, Assistant Registrar (Dog lover) with the help of the officials of the MCD.
 - v. Coyote Rollers should be fixed at all the gates of the University for avoiding entry of stray dogs in the University Campus from outside of the University Campus.
 - vi. The Security Agency shall ensure that no stray dogs be allowed to enter from the outside of the University.
 - vii. As desired by the Dy. Director (Veterinary Services), Najafgarh Zone, MCD, it should be ensured by the residents of the University Campus that:
 - a) Pet dog should be leash with muzzle by the concerned residents when dog in outside of the house.
 - b) Pet dogs should be registered by the residents of the University Campus with MCD.
 - viii. Sh. Sunil Kumar (Assistant Registrar), will co-ordinate with Dy. Director (Veterinary Services), Najafgarh Zone, MCD and with other Officials/Officers regarding issues of the stray dogs from time to time.


