NOTIFICATION

In the 50th meeting of the Academic Council of the University vide agenda item no. 50.41, the following decision has been taken in reference to intermediate semester / annual examination for the University in Academic Session 2020-2021:

“The Academic Council has decided that considering the pandemic situation in Delhi, the University shall adopt the same method of promotion of intermediate semesters / annuals for even semester/annual of Academic Session 2020-2021, which was applied to the Academic Session 2019-2020 for the even semester or annual. The examination of final year shall be held online proctored examinations. It was also informed that in case any guidelines shall be issued by the concerned statutory body, shall be applied for the concerned programme.”

Further, the University had issued a Notification dated June 8th, 2020, regarding guidelines / policies related with results / conduct of exam for intermediate / final semester / annual students for all UG and PG programmes for the academic session 2019-20, the same guidelines / policies will be followed / implemented for the academic session 2020-21:

- Conduct of pen and paper mode as well as online exams for final semester/year students.
- No exams to be conducted for all intermediate semesters/years and their unconditional promotion to next semester/year. The students would be promoted to the next semester on the basis of composite 50% weightage to marks in the previous semester/year only and 50% weightage of marks in internal assessment of the current semester in each subject.

“The carry forward (for the subjects in which the student has failed in previous year/semester) would be allowed for the current academic semester/year and every student would be promoted to the next semester/year, irrespective of the approved promotion criteria. However, such students would be required to clear the examinations for the subject / course in which he/she is failed/ remained absent as and when examinations are held for the same in future.

Any student of intermediate semester/annual, who wishes to improve his result in any of the subject/course for the current semester under promotion criteria, can opt to appear in the examination, whenever they are held in the succeeding year.

This notification will not be applicable to Programs under the control of statutory bodies such as Council of Architecture for B.Arch., Medical Council of India, Dental Council of India, Central Council of Indian Medicine, Central Council of Homeopathy (CCH), Indian Nursing Council, Rehabilitation Council of India, Delhi Council for Physiotherapy and Occupational Therapy, which shall continue to follow the examination schedule and methodology prescribed by the respective regulatory / statutory bodies.”
