In addition to teaching Corporate Law, International Law, Conflict of Laws, Arbitration, and Mediation for over three decades in top Brazilian and International Law Schools, he is a specialist in Development Law (IDLO-Rome), a Master and a Ph.D. in Corporate Law (UFPR-Brazil), holding a LL.M Degree in Dispute Resolution from the Straus Institute for Dispute Resolution/Pepperdine University (U.S.), where he teaches an ADR segment at the U.S. Law, Legal English, and ADR summer seminar and has also been appointed as Ambassador, in 2019. Besides being a Research Advisor at the South Ural State University (Russia), Professor Gevaerd is currently the President of the International Editorial Board of the ADR Brazilian Law Journal, published by the CBMA-Brazilian Centre of Mediation and Arbitration (Rio de Janeiro), where he also sits as International Director of Academic Affairs.
