Master's degree (Two years) course in Environment Management which aims to equip the budding environmental managers with a comprehensive understanding of the key environmental issues, and use of a wide range of environmental tools, methods and systems so that they can play leading role in the development and application of environmental policies and management in the public and private sectors. The course curriculum consists of four semesters which is optimal blend of theory and practice including:

- Dissertation (6 months)
- Summer internship (6 weeks)
- Compulsory field

The course gives in-depth and comprehensive knowledge about pollution management, environmental impact assessment, ecosystem functions and services, wildlife management, sustainability, water resources, restoration, biodiversity, climate change, environmental policies and regulation. The programme trains the students as environmental professionals well-equipped to work in different sectors like industry, developmental projects as EIA professionals, climate change mitigation, energy technologies, pollution and health safety, geospatial technology professional, areas of ecosystem integrity and bio-remediation.
