- (2) Name of the applicant.
- (3) CET Code for which applied for.
- (4) Mobile Number of the applicant.
- (5) Correction Desired.

The email for correction, must be sent to the email-id specified for the appropriate CET Code / Programme as mentioned in the table as above. Sending incomplete email or to incorrect address / email-id shall lead to summarily rejection of the application for correction. Late applications for correction shall also be summarily rejected. Moreover incomplete information provided shall lead to rejection of request for correction.
