ADMISSION NOTICE 2019-20

Subject: Admission for foreign students to PhD programme of Guru Gobind Singh Indraprastha University for the Academic Session 2019-20

This is for the information of all the candidates seeking admission under Foreign National in PhD programme of the university for the Academic Session 2019-20.

Instructions:

- 1. The eligibility criteria as applicable for the Indian candidates (as per the ordinance 12 of the University as approved in the 65th Board of Management i.e. 15th June 2017) shall apply to the international students also. The applicants are advised to go through the ordinance available at http://www.ipu.ac.in/norms/phdbom210717.pdf and www.ipu.ac.in in Admissions 2019 for Admission Brochure for Ph.D programme for complete details.
- 2. The following shall apply with respect to the English proficiency:
 - (i) The international students seeking admission to the Ph.D Programmes foreign quota shall necessarily have to clear English proficiency exam (TOEFL or IELTS). TOEFL score 70 or IELTS band 6 shall be required for admission in all Schools other than University School of Humanities and Social Sciences (USHSS). However, TOEFL score 80 or IELTS band 7 shall be required for admission in USHSS. In the case of candidates applying on Indian Council for Cultural Relations (ICCR) Scholarships, the English proficiency score awarded and reported by the Council shall be considered as equivalent to IELTS score.
 - (ii) The candidates (from any foreign country) having completed their qualifying degree from India or a foreign centre of Indian University shall be exempted from the requirement of English Proficiency.

- (iii) The English proficiency documents must be submitted along with the Admission Form and other supporting documents.
- 3. International scholars applying for admission to Ph.D programme of the University shall have the option to indicate the preference of supervisor for their research. However, the allotment of supervisor to the scholar shall be made by the SRC and there is no guarantee that the preferred supervisor shall essentially be allocated to the scholar.
- 4. The applications of foreign nationals shall be evaluated on the basis of their synopsis, the details of which are available below. If the synopsis and other qualifications are found suitable by the concerned school, the application shall be accepted and the candidate be interviewed by SRC through video conferencing to test domain knowledge. The proposed project will be evaluated on the following grounds:
- (a) Topic, Introduction/Background (including brief review of relevant literature)
- (b) Research objectives
- (c) Methodology
- (d) Expected outcomes

If the synopsis and other qualifications are found suitable by the concerned school and the faculty with available slot and subject knowledge is willing to supervise the candidate, the application shall be accepted and the candidate be provisionally admitted.

The admission of the international students shall be within the allotted seats and there shall be no supernumerary seats.

5. Interested candidates should submit the duly filled-in application form (available in Appendix 1) to the office of the Director, Research and Consultancy latest by May 6th, 2019. No forms shall be accepted after that date.

6. The fee for foreign scholars admitted in PhD programme shall be as under-

(ii) For Developed Countries US\$ 1000
