NOTICE REGARDING ADMISSIONS TO BA LLB & BBA LLB (Code 121, LLB) AND LLM(REGULAR)(Code 112) FOR THE ACADEMIC SESSION 2019-20

Consequent to the directions of the Hon'ble Supreme Court dated 21/05/2019 (in SLP/Diary no. 18943/19) it is informed to all concerned that the admissions to the Code 121 (BA LLB and BBA LLB, 5 years integrated programme, BA/BBA LLB) for academic session 2019-20, to the University School of Law and Legal Studies and colleges/institutions affiliated to the University, shall be made on the basis of the merit of Common Law Admission Test — Under Graduate, 2019 (CLAT — UG, 2019), conducted by the Consortium of National Law Universities. The University shall not conduct its own CET for admissions to these programme, but shall be utilizing the score/merit prepared on the basis of (CLAT — UG, 2019) score/merit for admissions.

Besides above, it is further informed that admissions to LLM(Regular) -1 year programme (Code 112), for the academic session 2019-20, shall be made on the basis of the merit of Common Law Admission Test - Post Graduate, 2019 (CLAT - PG, 2019), conducted by the Consortium of National Law Universities. The University shall not conduct its own CET for admissions to this programme, but shall be utilizing the score/merit prepared on the basis of (CLAT - PG, 2019) score/merit for admissions.

All candidates desirous of seeking admissions to Code 121 (BA LLB and BBA LLB) Code 112 (LLM(Regular)) should fill up the application forms available on the University website www.ipu.ac.in. For application forms and further details see the admission brochure for Academic Session 2019-20 available on the University website www.ipu.ac.in.
