MEMORANDUM OF UNDERSTANDING

Between

Guru Gobind Singh Indraprastha University (GGSIPU), INDIA

And

Libera Università Maria SS. Assunta (LUMSA), Rome, ITALY

PREAMBLE

This MEMORANDUM OF UNDERSTANDING is entered into by and between the Guru Gobind Singh Indraprastha University (GGSIPU), Sector 16-C, Dwarka, New Delhi, INDIA, hereafter "GGSIPU", and the Libera Università Maria SS. Assunta (LUMSA), Rome, ITALY, hereafter "LUMSA"

GGSIPU and LUMSA are referred to collectively as "Parties" or individually as "Party". The parties agree to engage in cooperative programmes of education and research and to promote exchange among their faculty and students, in order to enhance the learning experience, and international understanding, on the basis of equality, mutual benefit and reciprocity; and thereof, the parties wish to define the broad terms and conditions under which they will engage in cooperative programmes.

1. Purpose/Objectives

The goal of this cooperation is to foster academic collaboration, provide opportunities for global experience and to facilitate advancement of knowledge on the basis of reciprocity, mutual benefits and frequent interactions. The parties agree to explore the possibilities of engaging in the following areas of collaboration

(a) Exchange of faculty for limited periods of time for purposes of education, research, training, and consultancy.

(b) Exchange of students at Undergraduate, Post-graduate, Doctoral and Post-Doctoral levels for limited periods of time for purposes of education, research, internship, and training.

(c) Joint organization of seminars, conferences, workshops and short-term continuing education programmes on topics of mutual interest.

(d) Joint proposal and engagement in research or training programmes sponsored by funding agencies.



(e) Introduction of joint twinning programmes in areas of high relevance to both the parties.

(f) Exchange of information on research, teaching, learning materials and other literature relevant to the parties.

2. Provisions for collaboration

2.1 Faculty-related collaboration

Both the parties to the MoU undertake to promote faculty-related collaboration for academic purposes.

(a) There may be mobility of the faculty members from one party to the other for short duration (no longer than one academic semester) on the terms and conditions agreeable to both parties.

(b) The faculty under mobility may be engaged in teaching programmes, participate in seminars, participate in executive & joint programmes, carry out research work to promote academic interests of both the institutions during the exchange duration.

(c) The request for exchange of faculty shall be duly forwarded by -

(i) the home institution in the form of a written proposal to the host institution. The proposal shall include the credentials of the visiting faculty member(s) and a description of the scope of the teaching or research which the faculty member(s) hope(s) to accomplish. The request shall also state the type of assistance or facilities which the faculty or researchers may require from the host institution; or

(ii) the host institution in the form of a written proposal to the home institution. The proposal shall include the type of expertise as required in respect of the visiting faculty member(s) and a description of the scope of the teaching or research which the faculty member(s) is (are) intended to be engaged with.

2.2 Student-related collaboration

Both the parties to the MoU undertake to promote student-related collaboration for academic purposes.

- (a) The host institution shall recognize the eligibility obtained by the candidate studying in home institution as per the norms of the country in which the home institution operates.
- (b) The student mobility programs shall be allowed for a minimum of three credits and maximum of two semester. The transcripts of credits obtained at the host institution shall be issued by the host Institution, and signed jointly by both the Institutions, and shall form part of the final transcripts of the student issued by the home institution. The transcripts issued by the host institution shall further be appended with the final transcripts.



- (c) The degree of the student graduating from GGSIPU, in collaborative arrangement with the Foreign Institution, shall be awarded only by GGSIPU and not by the Foreign Institution. The degree shall incorporate a para that it is being awarded in collaboration with the Foreign Educational Institution specifying the number of credits obtained from the Foreign Institution.
- (d) The credits awarded by the GGSIP University under the degree programmes covered in the collaboration, shall be accepted by the Host Institution not only for the collaboration but for all other purposes, including academic mobility. Further, the minimum duration of the programs of study, covered under the collaboration, in the Host Institution shall not be less than two semesters for undergraduate programs and one semester for the postgraduate programs.

2.3 Institution-related collaboration

Both the parties to the MoU undertake to promote institution-related collaboration for academic purposes.

(a) The parties may mutually decide to undertake institutional-level collaborative activities such as joint conferences/seminars/workshops, extramural grants/projects, or other similar activities.

3. Costs, Finances, Fees and Insurance

- (a) Each party will be responsible for its own costs related with the administration of the collaborations under this MoU.
- (b) For institution-related collaboration, each party will be responsible for its own costs in connection with all matters relating to collaborations under this MoU. The terms and conditions for each activity, including those concerning stipend, travel, and housing, etc, would be worked out between the parties.
- (c) For faculty-related collaborations, each party will be responsible for its own costs in connection with all matters relating to collaborations under this MoU. As a norm, the travelling cost shall be borne by the home institution, boarding and lodging cost shall be borne by the host institution and the stipend etc shall be worked out mutually by both the parties.
- (d) The terms and conditions for each exchange or assignment, including those concerning stipend, travel, and housing, etc. would be worked out between the parties.
- (e) For student-related collaborations, the home institution shall pay a proportionate amount of the academic fee (credits earned at the



host institution as against total credits of the semester/year/program) to the host institution. The students shall be responsible for their own transportation to and from the host institution, as well as for the boarding, lodging, insurance, and any other necessary expenses while attending the host institution.

- (f) In the case of the visa not getting stamped in case of studentrelated collaborations, the loss of visa fee shall be borne by the student concerned.
- (g) In the unforeseen circumstances of the candidate not being able to depart for the host institution despite all the approvals, the candidate under reference shall bear all the costs that remain unadjusted at the end of the parties for the case.

4. Administration

The administration of this MoU shall be the responsibility of the Directorate of International Affairs (DIA) at the GGSIPU and the Rector at LUMSA.

5. General Provisions

- (a) Any specific joint projects with legally binding obligations will be set forth in separate written agreements.
- (b) Treatment of intellectual property rights developed through collaborations under this MoU will be determined between the parties through mutual consultation and separate written agreements on a case to case basis. In any case, the support of both the partnering institutions shall be duly acknowledged for all academic products having IPR value.
- (c) All activities conducted under this MoU will be in accordance with the applicable rules and regulations of the home and host institutions, and all applicable federal, state and local laws, rules and regulations of the concerned countries.

6. Confidentiality

Each party shall treat as confidential and shall not disclose to any person/organization the terms of this MoU or any information or materials supplied or made available in connection herewith without the other party provided, however the party may disclose such information as required by law of the land. The provision shall survive termination or expiration of this MoU.

7. Duration, Revision and Termination

(a) The MoU shall become effective on the date that it is signed by both parties and shall be valid for five years.

(b) The MoU may be revised through the mutual agreement of both the institutions and the approval by the regulatory authority in the

concerned country, wherever so required by the law.

(c) This MoU may be terminated by either party at any time provided that the party who wishes to terminate gives written notice of its intention at least three months prior to the termination. However, ongoing collaborative activities of any kind shall be allowed to conclude irrespective of the termination of this MoU.

8. Obligations

8.1 Both the parties agree to jointly solicit for funds including the donor funds, research grants, contributions, subscriptions and such related funds for the purpose of realizing any or all the objectives of the collaboration.

8.2 Both institutions shall abide by current international guidelines on good research practice and ethics available in relation to all

research activities.

8.3 Both the parties shall make rules governing the use of respective facilities including laboratories, library and workshops where such facilities are used to conduct any of the functions of this collaboration.

8.4 Both the parties shall make rules relating to entitlement, selection, procedures, etc., for intended beneficiaries of the

respective institutions.

MEMORANDUM OF UNDERSTANDING

PREAMBLE

The parties agree to engage in cooperative programmes of education and research and to promote exchange among their faculty and students, in order to enhance the learning experience, and international understanding, on the basis of equality, mutual benefit and reciprocity; and thereof, the parties wish to define the broad terms and conditions under which they will engage in cooperative programmes.
