6. **PROOF OF DATE OF BIRTH** : (As per matriculation certificate)
7. **CHARACTER CERTIFICATE**: Conduct and Character Certificate from the Head of the Institution from where the qualifying examination has been passed or from Gazetted Officer, not more than six months old (in original).

8. RESERVATION POLICY (Refers Chapter VI of Admission Brochure 2021-22 available on University website).

- a. The reservation certificate would be issued from the respective State/region in which the reservation is claimed e.g. in case any candidate claims for the seat reserved for DSCs/DSTs category then he /she has to bring SCs/STs certificate issued by Govt. of NCT of Delhi and also should have passed his/qualifying exam from Delhi.
- b. SCs/STs Physically Handicapped /Defence Category/ Kashmiri Migrants whichever applicable, on the basis of which reservation is claimed (Original and One Photocopy).
- c. The provision for reservation in OBC category is not applicable for Post graduation/ Master level Programmes. However, the OBC category candidates may claim seat in General category in the order of their rank as per merit, as per their respective regions.
- d. For Clarification on region i.e. Delhi or Outside Delhi and reservation policy, Candidates may please refer to the Chapter V: Seat allocation, Chapter VI: Reservation Policy of Admission Brochure 2021-22.
- e. Economically Weaker Section (EWS) Implementation of 10% reservation of Economically Weaker Sections, as per letter no. F.DHE.1(119)/Estt./2018-19/2549-76 dated 17.06.2019 in terms of OM No. F No. 12-4/2019-U1 dated 17.01.2019 issued by the Ministry of Human Resource Development, Department of Higher Education in this respect to give effect to the provision of the Constitution (One Hundred and third

Amendment) Act, 2019 for all higher educational institutions funded/aided, directly, or indirectly, by the Government of NCT of Delhi. The candidates shall be granted admission in EWS category subject to fulfilment of all the conditions as per rules of Govt. Note: 1 Reservation for EWS category is applicable only in University School of Studies and Govt. affiliated Colleges only. This will be implemented in accordance with the Govt. of India and Govt. of NCT of Delhi orders as applicable. 2 Reservation for EWS category is applicable for General Category Candidate only. Candidates claiming reservation for SC/ST/OBC Category will not be considered for reservation under EWS Category. 3 EWS Certificate should be issued after 31st March, 2021 stating valid for year 2021-22.

8. **MEDICAL CERTIFICATE:** Certificate of Medical Fitness to be signed by a Registered Medical Practitioner holding a medical degree in the format as given in Appendix-6 (original) of admission brochure – 2021-22.
9. A Bank Demand Draft of **Rs. 82,000/- (Eighty Two Thousand only)** in favour of “**Registrar, GGSIPU**” and payable at New Delhi.


10. FEE STRUCTURE :

1. Tuition Fee Rs. 75000/- per annum
2. Alumni Fee Rs. 1000/- (Non-Refundable)
3. Security Amount Rs. 5000/- (Refundable)
4. Admission Counselling Fee Rs. 1,000/- (Non Refundable)


11. Seat meant for reserve category remained vacant at the time of 1st Counselling will be converted in general category in absence of reserve category candidates during 2nd counselling and after 2nd Counselling seat in Delhi Region Category will be converted into Outside Delhi region or vice-versa during Open House Counselling.

The original documents shall be returned to the candidates after verification and the candidates shall be required to submit a self attested photocopy of such documents.

Note: The Candidates appearing for Counselling are required to strictly observe Covid-19 safety protocol; Government prescribed SOP including installation of *Aarogya Setu* Apps in their mobile.
