All CAT 2020, CMAT 2021& CET 2021qualified candidates who have been allotted seat in the previous rounds of Online Counselling including Spot Round and have paid the Part Academic Fee of Rs. 40,000/- and wish to participate in the Spot Round II Counselling, their part Academic Fee of Rs. 40,000/- (Rupees Forty Thousand only) paid in the earlier rounds of Online Counselling will be adjusted during the Spot Round II Counselling. Such candidates, if allotted a seat in the SPOT ROUND II Counselling need not have to pay the Part Academic Fee of Rs. 40,000/- again.
