1. All candidates who appeared in the CET conducted by the GGSIP University and subsequently appeared in the personal interview and whose names appears in the Final Merit List based on the CET / Personal Interview (attached as Annexure – ‘A’ to the schedule) shall report in person for 1st Round of Offline counseling for 'Verification of Documents' and 'Allotment of Seats', at the venue of counseling on the date and time mentioned below as per their Category and Rank. Details of Schedule is as below:

- (i) **Important Instructions in connection with Covid-19.**
 - a. All the candidates desirous participating in the Counselling process must follow the precautions / guidelines for Covid-19 passed by the Government from time to time.
 - b. Only the candidates with valid admit card and other documents will be allowed inside the University premises.
 - c. The candidates must wear mask and maintain social distance and strictly follow the seating arrangement at the venue of Counselling and other directions / instruction given in this regard.

(ii). Important:

- The Offline Counselling for Admissions to M.Sc (Packaging Technology) is made against the sanctioned intake for Indian Institute of Packaging, Plot No. 21-Patparganj Industrial Estate, Delhi-110092 Affiliated with Guru Gobind Singh Indraprastha University.
- A candidate belonging to any sub-category is also eligible to secure admission in General / Unreserved Category of his / her respective Region, purely on the merit of CET.
- The conversion of seats reserved for SC, ST, OBC, Minority, etc. to General Category shall be done only after the completion of last counselling for the

reserved categories and no such conversion will be allowed during the 1st Round of counselling. However, while converting the seats, any unfilled seat(s) reserved for ST Category will be offered to SC Category and vice versa and only after that the conversion of the reserved category seats shall be effected.

- Allotment of Seats will stop as and when the seats get filled up.
- The Counselling for the seats reserved for any region / category shall be stopped as and when the seats in / of such category / region are filled up.
- The provisions for reservation in OBC category is not applicable for Post-Graduation / Master Level programmes. However, the OBC category candidates shall claim seats in General Category in the order of their rank as per merit, as per their respective regions.

4. Eligibility Criteria for Programmes for M.Sc (PT) Code: 604

A candidate seeking admission for the M.Sc. (Packaging Technology) should have passed the full time (not by correspondence or part time) Graduate degree examination in Science (12th+3 years degree entire 5 years in science only) with Physics / Chemistry / Mathematics / Microbiology or Biochemistry as the main subject or one of them as second subject in the three year degree or Agriculture / Food Science / Polymer Science or Engineering / Technology degree of a AICTE /recognized University with minimum second class. Those with equivalent overseas qualification would also be eligible for admission. The candidate needs to have consistently high academic performance and sound general knowledge. Candidates appearing in the final year of the qualifying examinations can also apply; however, they must submit their results/provisional results (as given by University) latest on the day of the personal interview and selection, as without their degree result, student are not eligible to appearing for personal interview and will be eliminated from the admission process.

Maximum Age 30 years as on 31/05/2020 (Age relaxation: 5 years for SC/ST)

Admission Criteria/Selection Procedure:

The admission to this Programme will be done according to the following two steps:

(i) Written examination and (ii) Personal interview

Selection Procedure:

STEP 1: Written Examination

A candidate seeking admission to the M.Sc. (Packaging Technology) will be required to appear in the written Entrance examination which will comprise of multiple-choice questions. The syllabus for the written test is at the graduate level and the subjects include Physics, Chemistry Mathematics and Engineering. The candidate has the option to choose questions, provided the number of question does not exceed a fixed limit. The entrance examination will be conducted at HO and RO's of the Institute. The Institute has the discretion to fix minimum qualifying marks for the examination and short list the candidates who will be eligible for further consideration for admission.

STEP 2: Personal Interview

Candidates, who clear the written examination as above, will be called for Personal Interview which will be held at HO and RO's of the Institute. The Institute has the discretion to fix minimum qualifying marks for Personal Interview which will make a candidate eligible for further consideration for admission. The final selection of candidates for admission to the course will be done in the order of their merit which will be based on the aggregate of marks calculated in each case according to the following weightage:

(i) Marks obtained in 12th Class/Sr. Secondary : 10%

(ii) Marks obtained in Graduation level : 20%

(iii) Marks obtained in the Entrance Examination : 50%

(iv) Marks obtained in Personal Interview : 20%

Display of 1st list will be based on the 1st round cut-off. The 2nd list displayed is on the basis of 2nd round cut-off. Further lists will be displayed on the availability of seats when necessary.

5. **Seat Matrix** – Approved Sanctioned Intake is 60. The reservations shall be applicable as per rules, to be displayed before the commencement of the Offline Counselling.

6. **Documents Required for Verification and Allotment of Seats:**


- a) Bank Draft(s) of Rs 41,000/- [this includes Rs. 1000/- Counselling Participation fee (non-refundable)] is required at the time of Counselling in favour of Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi. The candidate will write his/her name, date of admission, phone, address, mobile no, name of the programme, CET Rank and CET Roll Number on the back of the Bank Draft(s). Balance fee (if applicable) shall be paid by the candidate at the allotted Institute. The eligible Candidates in their own interest are advised to get their draft prepaid well in advance to avoid last time inconvenience.
- b) Four passport sized photographs (same as that in admit card)
- c) CET Rank Card of CET-2021
- d) CET-2021 Admit Card (in original) 2021.
- e) Copy of Admission verification form (Copy of Admission verification form as per Appendix 4A in Part E of Admission Brochure 2021-22.)
- f) Proof of date of birth (Secondary School Mark-sheet & Certificate) (Original and Photocopy)
- g) **Mark-sheets / Certificates of qualifying examination:**
The candidate will be required to bring the Original certificates/Mark-sheets of all the year wise or semester wise in original along with photocopy of Certificates/ Mark-sheets of qualifying examination.
- h) **Physical Fitness Certificate:**
All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate in given in Part E in Admission Brochure 2021-22 (As per Appendix 6).
- i) **Reserved Category Certificate:**
All reservation category candidates who are seeking admission in reserved category in SC / ST / DEF / PWD / EWS must bring their reservation certificate in original along with the self attested photocopy of the certificate for claiming seat against the reserved category. **The Defence Category candidates, in addition to all the documents, shall also bring Appendix 1 duly completed. The appendices are available in Part E of Admission Brochure 2021-22.**
- k). **Conduct and Character Certificate** in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, not more than 06 (six) months old.
- l). Application regarding age or any other relaxation with necessary approval (if necessary).
- m). The candidate claiming reservation against EWS category must produce certificate issued after 31.03.2021 by the Competent Authority and valid for year 2021-22 at the time of verification of documents and allotment of seats.

7. It will also be the sole responsibility of the candidates themselves to make sure that they are eligible and fulfill all the conditions prescribed for admission. Before filling-up the verification slip at the time of verification of documents / counselling/allotment of seats, candidate should ensure that he/she fulfils all eligibility conditions as laid down in the respective Admission Brochure for the session 2021-22. If it is found at any stage during the entire period of the programme that the candidate does not fulfill the requisite eligibility conditions, his / her admission will be cancelled and also disciplinary action will be initiated against his / her and entire fee will also be forfeited.

8. Date and time of Withdrawal of Admission

Last date of Withdrawal upto 26.11.2021 (04.00 p.m). The refund shall be processed as per the notified Refund Policy 2021-22 of the University, shall mandatorily be submitted in the prescribed format available in Part E, Admission Brochure 2021-22, (Appendix-8). The same shall be submitted in the Admissions Branch, Administrative Block, Guru Gobind Singh Indraprastha University, Sector 16C, Dwarka, New Delhi-110078. A proper receipt for withdrawal will be issued in lieu thereof.
