NOTICE

Directorate of Higher Education, Govt. of NCT of Delhi vide Notification No.DHE 18(14)/SFRC(4th)/2017-18/3781-91 dated 2nd August, 2019, had notified the revised fee as per recommendations of the 4th State Fee Regulatory Committee, in respect of Self Financing Institutes located in Delhi, however, in the Notification erroneously the DHE missed out mentioning the revised fee in respect of some programmes in six Self Financing Institutes located in Delhi affiliated to GGS Indraprastha University

Directorate of Higher Education, Govt. of NCT of Delhi vide Notification No.DHE 18(14)/SFRC(4th)/2017-18/1160-70 dated 18th September, 2020, notified, the revised fee as per recommendations of the 4th State Fee Regulatory Committee, in respect of left out programmes in six Self Financing Institutes located in Delhi affiliated to GGS Indraprastha University.

As per the Notification referred above dated 18.09.2020, the said fee shall be applicable for students admitted in the Academic Year 2019-20. Further, 4th State Fee Regulatory Committee has submitted its supplementary report with the recommendations of following fee structure for the left out courses:-

The Notification dated 18.09.2020 further states "now, in exercise of the powers conferred by sub-sections (3) and (13) of section 6 of the said Act, the Lt. Governor of the National Capital Territory of Delhi hereby notifies that the above proposed fee shall be applicable from the Academic Year 2019-20 onwards as is the case with other colleges/courses notified by the Governor of the National Capital Territory of Delhi".

In addition to above, as stated, the University charges of Rs.15,000/- per annum (for students admitted in Academic Session 2020-21) Security Amount (one time) of Rs.5,000/- and student Activity Fee of Rs.1,000/- per annum. The Security Amount (one time) is Refundable from the respective College/Institute.
