CIRCULAR

An Inter-sectoral Coordination Committee Meeting was held under Chairmanship of SE-1/NGZ Zone on 25th June, 2021 at Conference Room, Ist Floor, SDMC, Najafgarh Zone to review preparation and contribution to be made by Inter-sectoral Department for Prevention and Control of Vector Born Diseases in Najafgarh Zone for the year 2021-22. The following key points were emphasized:-

Dengue, Malaria & Chikungunya are vector borne diseases transmitted by bite of mosquitoes. Since there is no specific treatment against Dengue & Chikungunya, prevention of mosquito breeding by source reduction is the

only effective tool for prevention and control of these diseases.

Vector Mosquitoes breed mainly in artificial collection of clean water like, desert coolers, uncovered overhead tanks/water storage containers, old tyres or any other article holding water. During rainy seasons unattended/waste articles lying on roof top or in open area get filled with rain water and provide ideal place for breeding of Vector mosquitoes.

Keeping in view of the above, following preventive measures are to be taken:-

(i). Collection of stagnant water should not be allowed inside or around office premises.

(ii). Unused/broken bottles, plastic cups, pots, containers, broken utensils & tyres etc. that can hold water

should not be left in the open.

(iii). Clean & dry coolers atleast once a week. Put diesel/petrol/temephos granules in those coolers which cannot be emptied.

(iv). Change water of bird pots regularly.

(v). Overhead and other water tanks should be kept covered by tight fitting lid. Put net/cloth on overflow/air

(vi). Change water of money plants/indoor plants every week.

(vii). All breeding sources to be destroyed.

(viii). All the students / staff should wear full sleeve clothes and trousers / pants to avoid mosquito bites.

necessary directions to students.
