1. Physical Submission of Application Form

All the candidates seeking admission on the basis of merit in GGSIPU CET are hereby instructed that they have to carry out Registration and also submit Application Form through offline Mode only by paying the requisite Registration Fee of Rs.1200/- as Demand Draft in favour Registrar, GGSIPU as applicable (non-refundable). The offline Registration Process shall commence w.e.f. 04.11.2022. The word "Registration" henceforth shall mean offline Registration as well as **submission of offline Application Form at Facilitation Centre, Sector-16 C, Dwarka, GGSIPU, New Delhi 110078.**

2. Physical Registration for participation is mandatory for appearing in CET in Post Basic B.Sc in Nursing Programme (CET Code: 188) for Academic Session 2022-23.

3. Eligibility Criteria for Programme- Post Basic B.Sc in Nursing CET Code 188.

The candidate should be a Registered Nurse and Registered midwife or equivalent with any State Nursing Registration Council.

Pass in General Nursing & Midwifery (GNM) with minimum of 55% aggregate marks.

The candidate should have undergone General Nursing & Midwifery (GNM) in an institution which is recognized by Indian Nursing Council.

Candidate should be medically fit.

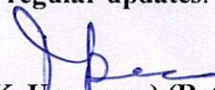
4. It is the sole responsibility of the candidates to ascertain whether he/she possesses the requisite eligibility and qualifications for admission.

All candidates must have appeared in the GGSIPU Entrance Test.
