#### ORDER

During the presentation of the Hon'ble Vice Chancellor in 10<sup>th</sup> meeting of 'The Court' of GGSIP University, held on 06.08.2021, the following was observed:

"The members appreciated the University efforts towards providing financial support to enable faculty to present their research work in national and international conferences by way of publication / processing charges, travel grant and annual research grant, etc. Hon'ble Chancellor enquired about the outcome of such Grants and advised to do the impact analysis duly evaluating the results as to how many such people succeeded and what are the benefits and achievements and accordingly decide before allowing financial assistance to the faculty".

In reference to the above observation, the Competent Authority, GGSIP University has constituted a Committee comprising of the following members:
