→ **THE SPECIAL ROUND OF COUNSELLING** WILL BE DONE FOR THE SEATS REMAINING VACANT AFTER REPORTING OF CANDIDATES AFTER SPOT ROUND II TO RESPECTIVE SCHOOLS OF STUDIES/COLLEGES/INSTITUTIONS AND ALSO VACANCIES ARISING DUE TO WITHDRAWAL OF ADMISSIONS/CANCELLATION OF ALLOTTED SEATS/ADDITIONAL INTAKE IN FEW COLLEGES/INSTITUTES IN MBA PROGRAMMES.

II) Who are eligible for SPECIAL ROUND OF COUNSELLING:

3. A candidate who was allotted a seat in the Online Counselling, paid the requisite Part Academic Fee of Rs. 40,000/- and subsequently withdrawn as per procedure.
4. A candidate who was allotted a seat in the Online Counselling, but did not pay the requisite Part Academic Fee of Rs. 40,000/-.
5. A candidate who has not been allotted any seat in any rounds of the Online Counselling.
