- → THE SPECIAL ROUND OF COUNSELLING WILL BE DONE FOR THE SEATS REMAINING VACANT AFTER REPORTING OF CANDIDATES AFTER SPOT ROUND II TO RESPECTIVE SCHOOLS OF STUDIES/COLLEGES/INSTITUTIONS AND ALSO VACANCIES ARISING DUE TO WITHDRAWAL OF ADMISSIONS/CANCELLATION OF ALLOTTED SEATS/ADDITIONAL INTAKE IN FEW COLLEGES/INSTITUTES IN MBA PROGRAMMES.

II) Who are eligible for SPECIAL ROUND OF COUNSELLING:
