

### III) IMPORTANT NOTE:



- (b) Candidates, desirous of participating in the Special Round of Counselling on the basis of CAT 2021, CMAT- 2022 and CET -2022, must have to fill their fresh choice/ preferences. All previous choices shall be treated as null and void.
- (c) Filling of Fresh Choices is mandatory for all the applicants seeking admission during Special Round of Counselling for Academic Session 2022-23.
- (d) Special Round of Counselling will be held ONLY for the candidates who will fill their fresh choices ONLINE for Special Round of Counselling for Academic Session 2022-23.
