#### **NOTE:**

Candidates are advised to refer the various notices and advisory of AACCC, Ministry of AYUSH regarding Schedule of Counselling and Eligibility for admission in AYUSH UG program uploaded on their website time to time.

Any change in reservation policy, if taken by the Government of India/NCT of Delhi or the University, the counselling will be conducted in accordance to that.

All counseling shall be held according to the directions of the statutory regulatory body, Govt. of India, Govt. of NCT of Delhi, Hon'ble Court(s) and/or the University.

THE UNIVERSITY SHALL CONDUCT THE ROUND II THROUGH OFFLINE MODE FOR ADMISSION IN PROGRAMS BAMS (CODE 153) AND BHMS (CODE 154) ON THE BASIS OF MERIT FROM AMONG THE NEET UG 2022 QUALIFIED CANDIDATES WHO HAVE REGISTERED WITH THE GGSIP UNIVERSITY AND HAVE ALSO PAID THE FEE OF RS. 1200/- AND RS.1000/-.

**IMPORTANT NOTE:** ALL THE CONCERNED CANDIDATES ARE ADVISED TO STRICTLY ADHERE TO THE BELOW INSTRUCTIONS.

- i) The admissions/allotment of seat shall be based only on the merit of NEET UG 2022 from among the registered students subject to verification of documents and fulfilment of eligibility for allotment of seat as per the regulations of the University/Statutory Body.
- ii) It is mandatory for all the candidates to attend the counselling in person at the University Dwarka Campus along with their original documents and photocopies (for retaining in file).
- iii) Candidates essentially shall produce the original certificates at the time of counselling/allotment of seat. However, the seat allotment shall be as per the norms of AYUSH regarding the eligibility to participate in counselling.
- iv) Candidates shall be submitting an undertaking of not having admitted / joined any seat in BAMS/BHMS consequent to the conduct of Counsellings through AIQ/Deemed/or any other State Counselling etc. and such candidates shall not be granted any seat in this round of counselling. In the event, the candidate undertaking or any other document is found to be false, the admission of candidate shall be cancelled at that stage of the programme.
- v) CANDIDATES ADMITTED THROUGH THIS COUNSELLING SHALL JOIN IN THEIR ALLOTTED COLLEGE TILL 23<sup>RD</sup> DECEMBER, 2022, FAILING WHICH, THEY SHALL HAVE NO CLAIM ON THE ALLOTTED SEATS AND THEIR ADMISSION SHALL BE TREATED AS CANCELLED.
- vi) Number of tentative seats available for Round II Offline Counselling is already detailed above. The final category wise vacant seat status shall be displayed/announced at the counselling venue.

#### **I. ELIGIBILITY FOR PARTICIPATION IN ROUND II FOR BAMS & BHMS PROGRAM:**

- (a) NEET (UG) - 2022 qualified candidates who have not registered in the 1<sup>st</sup> Round, however, have registered themselves in 2<sup>nd</sup> Round and have also paid Rs. 1200/- and Rs. 1000/-.
- (b) Registered candidates who did not get any seats in the 1<sup>st</sup> Round.
- (c) Registered Candidates allotted seat in 1<sup>st</sup> Round, however did not pay the requisite Part Academic Fee of Rs. 40,000/-.
- (d) Candidates allotted seat in Round 01, paid the requisite Part Academic Fee of Rs. 40,000/-, however did not report at the allotted college. **Note: Such candidates are informed to deposit demand draft of Rs. 40,000/- again. The Part Academic Fee already paid through Online shall not be adjusted.**
- (e) Candidates who were allotted seat in Round 01 and have subsequently opted for withdrawal within the notified scheduled date and time.
- (f) Candidates allotted seat through Round 02 counselling conducted by AACCC/Central/State/UT across the country and have not joined/not reported to the allotted seat are eligible for further counselling. Further, the candidates who have joined the allotted seat after Round 02 and exit/resign the allotted seat 3 days prior to the commencement of the 3<sup>rd</sup> round are also eligible for further counselling (Central/State/UT). All such candidates shall have to submit an Undertaking for consideration of provisional allotment of seat.

- (a) If any vacancy sub-categories (i.e. Defence and PWD/PH) exist and the same remains vacant, then they shall first be reverted to that respective parent category.
- (b) Thereafter, the conversion of SC, ST, OBC to General Category shall be done only during the 2<sup>nd</sup> round counselling. While converting the seats in round II, any unfilled seat reserved for ST category will be offered to SC category and vice versa and only after completing this exercise, the conversion of the reserved category seats to General Category shall be effected. However, any OBC vacant seat shall be directly converted to General Category.
- (c) All the candidates claiming seats in Defence Priority (I to IX) shall visit the University on the notified date and time. The University will call candidate's priority wise for verification of documents and allotment of seats within the notified date and time. **They should mandatorily submit duly filled and signed Appendix 1 of Admission Brochure along with supporting documents.**
- (d) Candidates are requested to refer to the tentative seats available for Round II Counselling. All the candidates will be called accordingly to ensure that no seat remains vacant. However, the counselling shall stop as and when the seats are filled up.
- (e) Any category candidate, which have not been called and/or whose vacancy does not depict in the 'vacancy position' may attend the counselling as an unreserved category candidate and/or the vacancy may arise consequent to the conversion of categories during Mop-round of counselling.
- f) **CUT-OFF percentile and score as per order/directions of Ministry of AYUSH.**

#### **IV. FEES TO BE PAID AT THE TIME OF COUNSELLING/ALLOTMENT OF SEAT:**

A candidate will have to mandatorily bring a Demand Draft of Rs. 40000/- in the name of **REGISTRAR, GURU GOBIND SINGH INDRAPRASTHA UNIVERSITY**, payable at **DELHI**. Balance fees, if any, shall be paid by the candidate directly in the respective allotted college.

**NOTE:** Candidates who were allotted seat through Round 1 Online Counselling in programs BAMS & BHMS conducted by the University during the academic session 2022-23 and paid the Part Academic Fee of Rs. 40,000/-, however, he/she did not report at the allotted college or have subsequently withdrawn their admission **need to submit the demand draft of Rs. 40,000/- for allotment of seat in Round 2 Offline Counselling at the counselling venue.**

- ix) **Character Certificate** from the head of the Institution from where the qualifying examination was passed or from Gazetted Officer (not more than 6 months old).

- xi) Appendix 1, Admission Brochure 2022-23 duly filled and signed in original, along with the relevant entitled certificates, if admission is claimed in '**DEFENCE**' Category.
- xii) Medical Certificate (as per Appendix of Admission Brochure 2022-23).
- xiii) The candidate shall have to be present in person for the purpose of verification of documents and allotment of seats as the schedule.
- xiv) The candidate must produce original certificate for the purpose of verification of documents and allotment of seats.

### **VI. REPORTING OF CANDIDATES TO THE ALLOTTED INSTITUTE/COLLEGE:**

The candidates are required to report at the respective college/institute along with the Provisional Admission Slip by **23<sup>RD</sup> DECEMBER, 2022**. The candidates may also have to pay the balance amount of fees (if any) at the respective allotted college/institute.

### **VII. IMPORTANT NOTE:**

- a. The admission of students, who fail to fulfil the minimum eligibility criteria mentioned in the Admission Brochure or as stated by the Statutory Body or fail to produce the adequate documents for eligibility and reservation, will be cancelled.
- b. **NO PROVISIONAL ADMISSION WILL BE DONE FOR ANY RESULT AWAITED OR COMPARTMENT / SUPPLEMENTARY CASES.**
- c. Registration is mandatory in the respective Programme/Course for participating in Counselling/Admission.
- d. Candidates are advised to visit regularly the University Website [www.ipu.ac.in](http://www.ipu.ac.in) as well as the online admission website <https://ipu.admissions.nic.in> till the admission process for Academic Session 2022-23 concludes.
- e. Conduct of Counselling for Round 2 (including verification of documents & allotment of seats shall be held offline in the University campus).
- f. The University will not consider any claim for allotment of seat in the reserved category on the basis of any undertaking. If any such candidate's claim has been inadvertently verified and he/she manages to secure a seat, during physical verification of documents at the time of counselling/allotment of seats, reporting at the allotted college or thereafter, at any stage, the admission shall be cancelled and the entire fee shall be forfeited.
- g. The candidates claiming reservation in categories such as ST DEF, SC DEF, OBC DEF, ST PWD, SC PWD, OBC PWD etc. shall have to produce relevant certificate of reservation for both the Primary and Sub Categories.


