**NOTICE - BACHELOR OF PHARMACY (B.PHARMA) (CET CODE 133) AND PARAMEDICAL (BPT/BOT/BPO/BASLP/B.SC (MLT) (CET CODE 124)****SCHEDULE OF ENROLLMENT FOR CENTRALIZED ONLINE COUNSELLING FOR SPOT ROUND- II FOR ADMISSION FOR ACADEMIC SESSION: 2022-23**

This is for information of all the stakeholders that the University is in the process of commencement of Registration for Centralized Online Counselling for Spot Round -II the Academic Session 2022-23 is detailed below:-

The Schedule for Registration followed by other connected activities for Centralized Online Counselling for Spot Round -II for the seats remaining vacant after SPOT Round I and reporting of such candidates admitted in respective University Schools of Studies/ Colleges/Institutions is as given in the succeeding paras:

**I) WHO ARE ELIGIBLE FOR SPOT ROUND -II OF ONLINE COUNSELLING:****ADMITTED CANDIDATES**

1. A candidate who was allotted a seat in the Online Counselling, paid the requisite Part Academic Fee of Rs. 40,000/- and reported at the allotted college/institute in the notified date & time.

**NOT ADMITTED CANDIDATES**

2. A candidate who was allotted a seat in the Online Counselling, paid the requisite Part Academic Fee of Rs. 40,000/- but did not report at the allotted college/institute in the notified date & time.
3. A candidate who was allotted a seat in the Online Counselling, paid the requisite Part Academic Fee of Rs. 40,000/- and subsequently withdrawn as per procedure.
4. A candidate who was allotted a seat in the Online Counselling, but did not pay the requisite Part Academic Fee of Rs. 40,000/-.
5. A candidate who has not been allotted any seat in any rounds of the Online Counselling.
6. All the registered candidates who have paid the Application Fee of Rs. 1200/- and the Counseling Participation Fee of Rs. 1000/- but did not fill choices.
7. All 'Not Admitted' candidates.
8. Allotted candidates who had chosen Freeze / Float options.

**II) SPOT ROUND -II PROCEDURE:**

- a) Registration for Spot Round -II will be for all CET 2022 qualified candidates/ National Level Test qualified candidates irrespective of his/her registration earlier.
- b) All the already Registered candidates and registering afresh will be allowed to login after accepting the terms and conditions of Spot Round -II.

1.	Candidates whose name appeared in Common Merit List Rank 2022 of GGSIP University and have paid Rs. 1000/-(Non-Refundable) towards counselling participation fees.	Such candidates are required to again register and <u>pay Rs. 500/- (Registration Fee is only to be paid by a candidate who is participation in the Spot Round for the First time)</u> (Non-Refundable) through Net Banking/Credit Card and Debit Card towards Participation in Spot Round II Counselling.	21.11.2022 (10:00 am)	23.11.2022 (11:50 pm)
2.	Candidates whose name appeared in Common Merit List Rank 2022 of GGSIP University but have not paid Rs. 1000/- (Non-Refundable) Counseling participation fee. **V) CHOICE FILLING**

- CANDIDATES DESIROUS OF PARTICIPATING IN THE SPOT ROUND - II OF COUNSELLING MAY ADD / DELETE / MODIFY THEIR CHOICES/PREFERENCES. ALL THE CHOICES/PREFERENCES FILLED BY THE CANDIDATES TILL SPOT ROUND- I SHALL BE TREATED AS NULL AND VOID. CANDIDATES PARTICIPATING IN SPOT ROUND II SHALL HAVE TO FILL CHOICES/PREFERENCES AFRESH FOR ALLOTMENT OF SEAT.**
- THE CANDIDATES WHO HAVE REPORTED AT THEIR RESPECTIVE SCHOOL OF STUDIES/COLLEGES/INSTITUTION AFTER SEAT ALLOCATION UPTO SPOT ROUND I, IF PARTICIPATING IN THE SPOT ROUND - II ARE ASSURED THAT IF ANY OF THE NEW PREFERENCES FILLED IN THE SPOT ROUND - II IS NOT ALLOCATED TO THEM, THEIR EXISTING ALLOCATION OF SEAT SHALL BE RETAINED AND SHALL NOT CHANGE.**
- The candidates who have reported at their respective School of Studies/Colleges/Institution after seat allocation upto SPOT Round I, if participating in the Spot Round -II and if any of the new preferences filled is allocated to them in the Spot Round - II of Counseling, then, the candidate shall be abide to take the new allocated seat and they will not have any claim on their previous allotted seat.**

**\*\*\* Adjustment of Part Academic Fee in SPOT ROUND II of Online Counselling:**

**Candidates whose name appeared in Common Merit List Rank 2022 of GGSIP University, who have been allotted seat in the previous rounds of Online Counselling and had paid the Part Academic Fee of Rs. 40,000/- and participated in the Spot Round II of Counseling, their part Academic Fee of Rs. 40,000/- (Rupees Forty Thousand only) paid in the earlier rounds of Online Counselling will be adjusted during the Spot Round II of Online Counselling. Such candidates, if allotted a seat in the SPOT ROUND II of Online Counselling need not pay the Part Academic Fee of Rs. 40,000/- again.**

**The following candidates need not to pay again the Part Academic Fee of Rs. 40,000/- (Rupees Forty Thousand Only) during admission in SPOT ROUND II of Online Counselling (i.e. if a seat is allotted in the Spot Round I of Counselling):**

- A candidate, who was allotted a seat in any round of Online Counselling and paid the Part Academic Fee and Reported.
- A candidate, who was allotted seat in online round of Online Counselling, paid the Part Academic Fee but did not report in the allotted institute.
- Any candidate, who was admitted in any round of Online Counselling, paid the Part Academic Fee and subsequently withdrawn as per procedure.

**Important Note:-**

- Admitted Candidates who are allotted an upgraded seat in the Spot Round -II of Counselling need to pay an additional amount of Rs. 5000/- at the newly allotted University School/Affiliated College in the form of DD in the name of Registrar, GGSIPU.
- The upgraded candidates have to pay the balance academic fee (if any), at the newly allotted college/institute/University School. The balance fee paid by such candidates in their previously allotted/reported college/institute shall be refunded to them by the respective college/institute at the earliest.
- It is the responsibility of the candidates to ascertain whether he/she possesses the requisite eligibility and qualifications for admission.
- Candidates upgrading a seat in the same institute/college (due to change in category/programme/shift) shall also report within stipulated date and time.

**VII) REPORTING OF CANDIDATES TO THE ALLOTTED INSTITUTE/COLLEGE:**

The following documents are required at the time of Reporting

- Four passport sized photographs (same as that in admit card)
- CET Rank Card/Merit Order and CET Admit Card 2022.
- Proof of date of birth (Secondary School Mark-sheet & Certificate) (Original and Photocopy)
- Mark-sheets / Certificates of qualifying examination:




- e) The candidate will be required to bring the Original certificates/Mark-sheets of all the year wise or semester wise in original along with photocopy of Certificates/ Mark-sheets of qualifying examination.
- f) For Distance / Open Learning Cases:  
In case of students who have passed the qualifying examination through distance / open education system of any recognized University / Board / Institution, the necessary documentary evidence related to location of his / her study centre i.e. study centre proof, certificate from the University imparting open / distance education certifying the location of the study centre to be submitted.
- g) Physical Fitness Certificate:  
All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate in given in Part-E in Admission Brochure 2022-23 (As per Appendix 5).
- h) Copy of Online Reserved Categories verification slip ( if applicable)
- i) Reserved Category Certificate:  
All reservation category candidates who are seeking admission in reserved category in SC / ST / DEF / PWD must bring their reservation certificate in original along with the self attested photocopy of the certificate for claiming seat against the reserved category. The Defence Category candidates, in addition to all the documents, shall also bring Appendix 1 duly completed. The appendices are available in Part E of Admission Brochure 2022-23.
- j) Conduct and Character Certificate in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, not more than 06 (six) months old.
- k) Application regarding age or any other relaxation with necessary approval (if necessary).
- l) The required Certificate(s) for reserved categories / classes will be essential at the time of the counselling / admission and no provisional admission shall be admissible for want of caste/category certificate from the local competent authority. Further, the caste / category certificate should invariably be in the name of the candidate himself / herself and not in favour of respective parents / guardians.
- m) Proof of payment of Part Academic Fee Payment receipt of Rs.40,000/ will be available in candidates profile-.,.

#### VIII) **IMPORTANT NOTE:-**


- a) **In Affiliated Colleges/Institutes of GGSIPU:** The balance amount of fees may be submitted through both Online (Net Banking/ Credit Card/ Debit Card) and Offline (through Demand Draft) as per the instructions issued by the respective Affiliated College/Institute.
- b) The Dean/Director/Principal will be responsible to ensure that the eligibility of all the students are checked by them to ensure correctness of admission specially in case of provisionally admitted students.
- c) It is the sole responsibility of the candidates to ascertain whether he/she possesses the requisite eligibility and qualifications for admission.
