- 1. B.E./B.Tech/ Post Graduation in Fire/ Fire Safety Engineering with minimum 50% Marks; Or
- 2. Bachelor's/ Post Graduation's degree in Civil/ Mechanical/ Eletrical/ Environmental Engineering/ Architecture/ Information Technology, with minimum 50% marks and having minimum relevant working experience of 3 years: Or
- Graduation/ Post graduation with minimum 50% marks, with STO/ DO course from NFSC or Grade I Fire E/MI Fire E from the institution of Fire Engineering /B.Sc (Fire / Fire Safety), having minimum relevant working experience of 3 years.
