Subject: Important points to be noted before applying for grant of provisional affiliation for Academic Session 2023-24

All the institutes who wish to apply for grant/ revalidation of continuation of provisional affiliation for Academic Session 2023-24 are hereby informed to note the following points before submitting their proposal for provisional affiliation:

- (i) In case any existing institute desires to apply new programme, it may be ensured that the institute had been given A or B category during last 02 academic sessions (As per clause 6.2 of Policy Guidelines dated 12.01.2016 of Govt. of NCT of Delhi). The institute should confirm from Directorate of Academic Affairs whether the new programme is approved by Academic Council of the University.
- (ii) In case any existing institute desires to apply additional intake in any existing programme, it may be ensured that admissions in the said programme during last 02 academic sessions are more than 75% of sanctioned intake (As per clause 6.3 of Policy Guidelines dated 12.01.2016 of Govt. of NCT of Delhi). Therefore, the institute can be allowed for increase of intake from 3rd year onwards from the introduction of the programme.
- (iii) In case any existing institute desires to apply for 2nd shift in existing programme, it may be ensured that the said programme has been running in 1st shift for atleast 02 years in the institute (As per clause 7.1 of Policy Guidelines dated 12.01.2016 of Govt. of NCT of Delhi).
- (iv) The institute already running 2nd shift are advised not to apply for closure of 2nd shift in any programme as already communicated earlier vide notice no. GGSIPU/DHE/(Aff)/2022-23/6443 dated 08/08/2022 (copy enclosed).
- (v) Every institute will have to provide calculation sheets for area requirement against the intake being applied by the institute (as per norms of respective Statutory Body/Govt. of NCT of Delhi)
- (vi) Every institute must ensure they have Fire Safety Certificate from Fire Service Department. A copy of the same must be attached with the proposal.
- (vii) The covered area shall be 225% of the land area i.e. permission FAR for considering programme/intake applied by the institute i.e. if any institute has a land area of 1000 sqm, the covered area for considering programme/intake will be 2250 sqm.
