## IMPORTANT NOTICE CONDUCT OF PHYSICAL COUNSELLING FOR 02 SEATS OF MD (PAEDIATRICS) IN CHACHA NEHRU BAL CHIKITSALAYA FOR ACADEMIC SESSION 2021-22

Reference: University notification no. 123/2021 dated 14.01.2022 regarding conduct of counselling by MCC for 04 seats of MD (Paediatrics) in Chacha Nehru Bal Chikitsalaya for academic session 2021-22.

The present Notification No. 125/2021 is in suppression of earlier University Notification no. 123/2021 dated 14.01.2022 referred above vide which all the concerned were informed that the admissions in 04 seats (02 State Quota & 02 All India Quota) of MD (Paediatrics) in Chacha Nehru Bal Chikitsalaya, Raja Ram Kohli Marg, Geeta Colony, New Delhi, for the session 2021-22, were to be carried out by the Medical Counselling Committee, DGHS.

The ADG (ME), DGHS, Govt. of India, vide their letter dated 17.01.2022 have now expressed technical difficulties in conducting the counselling for 02 State Quota seats and therefore all the concerned candidates eligible for GGSIPU State Quota seats are hereby informed that the admissions in 02 State Quota seats of MD (Paediatrics) in Chacha Nehru Bal Chikitsalaya, Raja Ram Kohli Marg, Geeta Colony, New Delhi, for the session 2021-22, shall be now carried out by the Guru Gobind Singh Indraprastha University, New Delhi.

Eligibility: Only candidates who have obtained their MBBS degree from the affiliated medical colleges of Guru Gobind Singh Indraprastha University, New Delhi are eligible for admissions to the State / Institutional quota seats.

Every candidate selected for admission to PGMC shall possess MBBS degree recognized by Medical Council of India and must have completed one year compulsory rotatory internship on or before Specified date of the admission year. The Candidate should have obtained permanent registration with the MCI or any of the State Medical Council. Only candidates who have obtained their MBBS degree from the Guru Gobind Singh Indraprastha University, Delhi are eligible for admissions to the State / Institutional quota seats.

Admission Criteria: All candidates must have appeared in the National Eligibility cum Entrance

Test - Postgraduate of 2021 (NEET PG 2021) and qualify to be considered for admissions.

All the concerned desirous of seeking admission in the 02 State Quota Seats of MD (Paediatrics) at Chacha Nehru Bal Chikitsalaya for the academic session 2021-22 need to apply in physical and submit their request addressed to "Registrar, GGSIPU" for participation for allotment of seat at the Facilitation Centre of Guru Gobind Singh Indraprastha University, Sector 16C, Dwarka, New Delhi latest by 31.01.2022 upto 01:00 p.m. along with the following documents:

- 1. Application with Subject "ADMISSION IN MD (Paediatrics)" request stating:
  - i) Name of the Applicant
  - ii) Father's Name
  - iii) DOB
  - iv) Address
  - v) Qualification (with name of the Institute and Year of Passing)
  - vi) NEET PG 2021 Roll Number & All India NEET PG 2021 Rank
- 2. NEET PG 2021 Rank Card.
- 3. Demand Draft of Rs. 2200/- (Non-Refundable Registration & Counselling Participation Fee) in favour of Registrar, GGSIPU, payable at New Delhi.
- 4. Photocopy of MBBS degree (only from affiliated medical colleges of GGSIPU).
- 5. Photocopy of One year compulsory rotatory internship certificate.
- 6. Photocopy of permanent registration with the MCI or any of the State Medical Council.

Note: Candidates who are already admitted to any Postgraduate Medical Degree/Diploma Course in any University/Institution as on the date of counselling will not be eligible for admission. Candidate will be required to give an undertaking/ Declaration in this respect at the time of counselling / admission.

Any change in reservation policy, if taken by the Government of India/NCT of Delhi or the University, the counselling will be conducted in accordance to that.

All counseling shall be held according to the directions of the statutory regulatory body, Govt. of India, Govt. of NCT of Delhi, Hon'ble Court(s) and/or the University.

The process of allotment of the 02 State Quota seats of MD (Paediatrics) shall be conducted by the University on 02.02.2022 at 11:00 a.m. in the GGSIP University Campus, Sector 16c, Dwarka, New Delhi. The detailed schedule regarding 'Documents required at the time of Counselling' shall be notified later.
