## **IMPORTANT NOTICE**

## Result Awaited Cases for Engineering and Professional Programmes (except B.Arch and NEET based admissions)

1. This has reference to Para 1 (i & ii) of clause 3.5 of Chapter 3 of Admission Brochure for the Academic Session 2022-23, the contents of which are reproduced as under:

## Result Awaited /Compartment/ Supplementary Cases

- i. All such candidates who have appeared in the qualifying examination (irrespective of the outcome of their final result) will be eligible to appear in the CET 2022-23 and all such candidates will be provisionally admitted in the respective programmes;
- The candidate will have to submit the final result of qualifying degree proving his/her ii. eligibility on or before 31st October 2022 to their concerned Dean/Principal/Director of their respective School/College/Institute where the admission has been granted provisionally. The concerned Dean/Principal/Director must submit the details of these result awaited provisionally admitted students within 7 days i.e. 7th November 2022 to Joint Registrar (Admissions), GGSIPU, 16 C Dwarka, New Delhi 110078. In case the candidate fails to submit his/her final result of qualifying degree in the manner as prescribed above to prove his/her eligibility on or before 31st October 2022, whatsoever, the reason may be, his/her admission will be treated as null and void (cancelled) and the entire fee will be forfeited and under no any circumstances he/she will be allowed to appear in the End Term Exam. No extension beyond 31st October 2022 shall be allowed by the University in any case. The Dean/Director/Principal will be responsible to ensure that the eligibility of all students are checked by them to ensure correctness of admissions especially in case of provisional students. The provisional admission will automatically stand cancelled if the candidates fail to submit result in time i.e. 31st October 2022.
- 2. However, it has been informed by some of the candidates that there is delay in declaration of final results of their respective Universities. Therefore, it is brought to the notice/information of all such candidates/stakeholders that in view of this, the University hereby extends the last date of eligibility as 15/12/2022 instead of 31/12/2022. The concerned Deans/Principal/Director must submit the details of these result provisionally admitted students within 7 days i.e. 22<sup>nd</sup> December 2022 to Incharge (Admissions), GGSIPU, 16-C

Dwarka, New Delhi 110078. The other content of the clause 3.5 of Chapter 3 of Admission Brochure 2022-23 shall remain the same and be strictly compiled with without any relaxation. No further extension beyond 15<sup>th</sup> December 2022 shall be allowed in any case.
