Sub: Constitution of Discipline –Specific SRC and Research Advisory Committee (RAC)


1. CONSTITUTION OF DISCIPLINE –SPECIFIC SRC:

In accordance with the clause 1.20 of Ph.D. ordinance 12 (2023), discipline –specific SRCs should be constituted in all USS where Ph.D programmes are offered in multiple disciplines. Each such SRC should have no less than three members from the concerned discipline. In cases where three members from the concerned discipline are not available in the concerned USS, either approved Ph.D supervisors with similar research expertise may be co-opted from any other USS/ Centre offering Ph.D programme in an allied discipline after approval of the Vice Chancellor; Or the SRC shall recommend a panel of atleast 5 subject experts of the concerned discipline from outside the University for the consideration and approval of the Vice Chancellor. These experts should preferably possess requisite qualifications equivalent to the requirement for recognition of a Ph.D. supervisor in GGSIPU. The Vice Chancellor may add/delete/change the name of the subject experts. In addition, there should be at least two common members in all such discipline-specific SRCs of the concerned School.

2. CONSTITUTION OF RESEARCH ADVISORY COMMITTEE:


The 'Research Advisory Committee' (RAC) should also be constituted for each Ph.D research scholar in accordance with Clause 8 of the Ph.D Ordinance 12 (2023). As per Clause 8.1 of the Ph.D. Ordinance 12 (2023) the members of the RAC shall be proposed by the supervisor for consideration and approval of the SRC of the concerned USS/Centre. If the total number of available members to constitute this committee is less than 5, then either approved Ph.D supervisors with similar research expertise may be co-opted from any other USS/ Centre offering Ph.D programme in an allied discipline after approval of the Vice Chancellor; Or the SRC shall recommend a panel of atleast 5 subject experts of the concerned discipline from outside the University for the consideration and approval of the Vice Chancellor. These experts should preferably possess requisite qualifications equivalent to the requirement for recognition of a Ph.D. supervisor in GGSIPU. The Vice Chancellor may add/delete/change the name of the subject experts.
