2. QUALIFYING MARKS/CUT OFF PERCENTILE:

In order to be eligible for admission to PGAC, it shall be necessary for a candidate to obtain minimum marks of percentile in the AIAPGET 2023 as per the minimum marks of percentile mentioned in the Central Council of Indian Medicine notification which is 50th percentile for General & EWS Category, 40th percentile for SC/ST/OBC.


For candidates with benchmark disabilities specified under the Rights of Persons with Disabilities Act, 2016 (49/2016), the minimum marks shall be 45th percentile for the General Category and 40th percentile for EWS (reference letter no. AA-11017/1/2023-EP-1 dated 05.10.2023 issued by AACCC – Counselling Cell (AEP-1 Section), Scheduled Caste, Scheduled Tribe and Other Backward Classes.
