1. This is in continuation to University's Notification No. 234/2023 vide no. IPU-7/Online Counseling/2023/4408 dated 19.09.2023 and 257/2023 vide no. IPU-7/Online Counseling/2023/4460 dated 27.09.2023 titled Schedule For "Mandatory Verification of Documents" on the basis of merit of CUET by the candidates who had applied in the University for various Programmes; Academic Session 2023-24.
2. List of Candidates whose documents got their verified on 22.09.2023, 30.09.2023 and 01.10.2023 (consequent to the University Notification No. 234/2023 dated 19.09.2023 and 257/2023 dated 27.09.2023) in order of tentative merit list already uploaded on the University website.
3. **Eligibility Criteria**  
The candidates are required to kindly go through the eligibility criteria laid down in the Admission Brochure for Academic Session 2023-24 available on the University Website [www.ipu.ac.in](http://www.ipu.ac.in) and Admission Website [www.ipu.admissions.nic.in](http://www.ipu.admissions.nic.in) for a particular programme / course. Seats shall be allocated on the basis of all India basis purely (i.e., without Regional distribution (Delhi & Outside Delhi) from among the registered candidates based on final merit which is annexed herewith.
4. The allotment of seats shall be carried out irrespective of region and category on All India basis, purely on merit of CUET.
5. **REFUND OF FEE:**  
The candidate will NOT be allowed for any kind of refund of fee after taking admission in this Round of Offline Counseling for Academic Session 2023-24.
6. **Documents Required for Allotment of Seats:**
  - a) Four passport sized photographs
  - b) Candidate will bring filled Admission verification form, which is **Compulsory**, as Annexed with this Schedule as Annexure 'A'
  - c) Preference Sheet (compulsory to be filled by Candidate- Annexure 'B')
  - d) Reporting Slip for Verification of Documents in original
  - e) Bank Draft(s) of Rs. 60,000/- in favour of Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi IS REQUIRED AT THE TIME OF ALLOTMENT OF SEAT. The candidate will write his/her name, date of admission, phone, address, mobile no., name of the programme, CML Rank notified by the University and CUET Roll Number on the back of the Bank Draft(s). **Balance fee has to be paid at their respective college.**

f) Proof of date of birth (Secondary School Mark-sheet & Certificate) (Original and Photocopy)

g) **Mark-sheets / Certificates of qualifying examination:**

The candidate will be required to bring the Original certificates / Mark-sheets of all the year wise or semester wise in original along with photocopy of Certificates / Mark-sheets of qualifying examination.

h) **Physical Fitness Certificate:**

All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in **Performa of Medical Certificate given in Admission Brochure 2023-24 (As per Admission Brochure 2023-24)**.

j) Conduct **and Character Certificate** in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, **not more than 06 (six) months old.**

**Important Note:**

- a) It is pertinent to mention here that all CET Qualified candidate whose status is 'NOT ADMITTED' is ALLOWED to take admission in this round of counseling. Any candidate who was ALLOTTED A SEAT IN SPOT ROUND -2 is NOT ELIGIBLE to take admission in this round of counseling.
- b) In Affiliated Colleges/ Institutes of GGSIPU, the balance amount of fees may be submitted through both online (Net Banking/ Credit Card/ Debit Card) / offline mode (Through Draft) as per the instructions issued by the respective Affiliated College / Institute.
- c) It will also be the sole responsibility of the candidate to ascertain and make sure that he/she possesses the requisite eligibility and qualifications prescribed for admission in various programmes. The candidates MUST go through the prescribed Eligibility conditions and Admission criteria as laid down in this Admission Brochure for 2023-2024.


