Eligibility:


Eligibility:

- For S.No. 2,5,6,7,8,9 & 10 A Master's degree (LLM) with 55% marks and must have cleared UGC NET and for S.No. 10 preferably practicing Advocate.
- For Serial no. 1, 3 & 4 Master's degree with 55% marks and must have cleared UGC NET.
- The qualification for Visiting/Guest Faculty shall be the same as those of regularly appointed Assistant Professors.

Selection Process:

- The candidates applying for assignment as Guest Faculty are required to appear before the selection committee with their CVs on 25.01, 2024 between 10 a.m. to 02 p.m. The interview will be held in Room No. 207 C Block, University School of Law and Legal Studies.
