OFFICE ORDER

In pursuance to University Circular No GGSIPU/COF/2013/600 dated 1st February, 2013 and in furtherance of that GGSIP University Medical Attendance Treatment Regulations 2000 (Revised) circulated vide order dated 15.07.2016, vide which, the terms and conditions of the Memorandum of Understanding (MoU) for empanelment of Hospitals, Dental and Eye Centres and Diagnostic Centres under the aforesaid regulation in cashless and non-cashless category were circulated.
