ADMISSION NOTICE FOR PROGRAMME D.PHARM IN CENTRE OF EXCELLENCE IN PHARMACEUTICAL SCIENCES (CEPS), GGSIP UNIVERSITY

The University is introducing a new programme **D.Pharm** as approved by Pharmacy Council of India (PCI) for the Academic Session 2024-25. The details of D.Pharm programme, duration and eligibility etc., for admission in this programme is given below.

Admission to D. Pharm

1. Diploma in Pharmacy course is a PCI approved short term programme of two year duration and is annual based. The programme aims to provide a thorough understanding of various subjects such as Pharmacognosy, Biochemistry, Clinical Pathology, Human Anatomy & Physiology and Pharmacology & Toxicology etc. This is a short term course which fulfills minimum qualification to be a registered pharmacist. Diploma in Pharmacy is a two-year course. The course duration is designed to provide students with foundational knowledge and skills in pharmaceutical sciences, drug formulation, dispensing and related areas. It's a relatively shorter program compared to a full-fiedged Bachelor's degree in Pharmacy (B. Pharm.) programme which is usually of four years' duration.

2. Eligibility Criteria:

The minimum age to pursue the D. Pharmacy eligibility is minimum 17 years as on date 31.12.2024 and the candidates must possess valid certificates of passing an examination and relevant qualifying examination to get enrolled in D. Pharmacy. Admission in D. Pharmacy would be on merit basis of the marks obtained in the qualifying examination. 	Admission shall be given on the basis of merit. Merit list shall be prepared on the basis of marks secured in 10+2.

3. Seat Allocation:

• 85% of the total sanctioned intake for Delhi Region

The candidates shall be considered as **Delhi Region Candidates** if they have passed the qualifying examination from any school located in NCT of Delhi. All such candidates shall be treated as **Delhi Region Candidates** for the purpose of counseling for admission.

- 15% of the total sanctioned intake for Outside Delhi Region
 The candidates shall be considered as Outside Delhi Region Candidates if they have passed the qualifying examination from any school/institute located Outside Delhi. All such candidates shall be treated as Outside Delhi Region Candidates for the purpose of counseling for admission.
- **4.** Reservation: As per the University norms as mentioned in Under Graduate Admission Brochure 2024-25.

5. Method of selection and admission:

- Based on the marks obtained in the qualifying examination, the University will prepare a list of candidates in order of merit. The merit list will be displayed on the University website.
- Admission on seats of different categories will be made on the basis of the result of the qualifying examination (12th).
- The inter-se merit of candidates securing equal aggregate marks at the qualifying examination will be determined according to the following criteria:
 - The candidate getting higher marks in PCM or PCB shall rank higher.
 - In case of a tie above, the candidate older in age shall rank higher.
- The date of counseling and admission, depending upon the rank of the candidate shall be displayed on the University website.
- Further, details regarding submission of form shall be displayed on the University website on **22.07.2024.**
