
**Note:**

1. This one seat is supernumerary in nature.
2. This one seat is filled up on All India Basis ie., without any Regional allocation (Delhi/Outside Delhi) as well as any other reservation viz SC/ST/Def/PwD/OBC/EWS etc. This seat shall be allotted purely on the basis of merit of applicable National Level Test/Common Entrance Test/Merit of Qualifying Examination, as the case may be.

**4. Eligibility Conditions**

Eligibility Criteria, for admission in a particular programme(s) shall be as per the Admission Brochure 2024-25. The candidates are required to kindly go through the eligibility criteria laid down in the Admission Brochures.

5. Merely submission of application form and participation in Counselling does not guarantee admission to the candidates in his / her choice of stream. The allotment of seat shall be purely on the basis of eligibility of the candidates. Inter-se-merit of the candidates shall be ascertained at the time of counseling and seats shall be allotted accordingly.



6. Guidelines pertaining to grant of provisional admission as mentioned in the Admission Brochure 2024-25 shall be adhered to.

7. **Documents required at the time of Counselling**

- (a) Bank Draft of Rs.96,000/- (ninety six thousand only) in the name of "Registrar, Guru Gobind Singh Indraprastha University", payable at Delhi. Balance fee will be deposited by the Candidate at the time of Reporting in the respective University School of Studies.
- (b) 4 passport sized photographs
- (c) CET/NLT Registrations details
- (d) Filled Admission verification form as per Appendix 6 of Part F of Admission Brochure 2024-25.
- (e) Proof of date of birth (Secondary School Mark-sheet & Certificate) (Original and Photocopy)
- (f) **Mark-sheets / Certificates of qualifying examination:** The candidate will be required to bring the Original certificates/Mark-sheets of all the year wise or semester wise in original along with photocopy of Certificates/ Mark-sheets of qualifying examination.
- (g) **For Distance / Open Learning Cases:** In case of students who have passed the qualifying examination through distance / open education system of any recognized University / Board / Institution, the necessary documentary evidence related to location of his / her study centre i.e. study centre proof, certificate from the University imparting open / distance education certifying the location of the study centre to be submitted.
- (h) **Physical Fitness Certificate:**All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate in given in Part-F in Admission Brochure 2024-25 (As per Appendix 5).
- (i) **Result Awaited:** candidates seeking admission as result awaited candidate must have to submit Appendix 4 of Part F of Admission Brochure 2024-2025.

8. It will also be the sole responsibility of the candidates themselves to make sure that they are eligible and fulfill all the conditions prescribed for admission. Before filling-up the verification slip at the time of verification of documents/counselling/allotment of seats, candidate should ensure that he/she fulfils all eligibility conditions as laid down in the respective Admission Brochure for the session 2024-25. If it is found at any stage during the entire period of the programme that the candidate does not fulfill the requisite eligibility conditions, his/her admission will be cancelled and also disciplinary action will be initiated against his/her and entire fee will also be forfeited.
