Sub: Ph.D. programme for Working Professionals in different disciplines of USS.

Ph.D Programme for Working Professionals in different disciplines of USS was approved in the 89th Board of Management vide Agenda Item no.BM 89.21 in its meeting held on 01.10.2025.

These Ph.D programme(s) shall have to be in consonance with the applicable Ph.D. Ordinance-12 and the UGC (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2022. Only those working professionals who have a minimum work experience of five years shall be eligible to apply under this programme. However, any working professional who wishes to pursue Ph.D in the University shall also be eligible to apply in various other Ph.D programmes that may be offered by USS/Centre of Excellence. USS/Centres of Excellence desirous of starting a separate Ph.D program for working professionals may hold a separate entrance test for these programmes in accordance with the UGC (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2022 and applicable Ph. D Ordinance-12 of the University.
