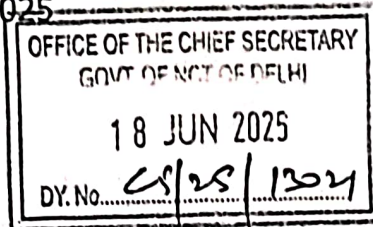

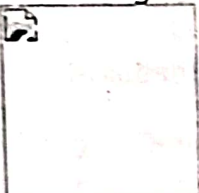

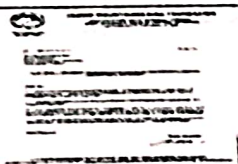

CIVIL – MILITARY TREKKING EXPEDITION IN “VIBRANT VILLAGE” ZEMITHANG

(ARUNACHAL PRADESH)

The Indian Army, in association with Indian Mountaineering Foundation, is conducting jointly Civil – Military trekking expedition in border areas of Kameng of Arunachal Pradesh during July, 2025. The initiative will provide an opportunity for youth of the country to explore border region and civil life in these areas, rich cultural heritage and traditions of Arunachal Pradesh, life of soldiers of Indian Army in challenging high altitude areas and experience military legacy of valour and courage.

Total Number of civil participants 15 participants is civil youth in the age group of 18 – 25 yrs.

Selection Male, youth from the entire country will be selected/ screened by IMF. All participants should preferably have done BMC from any Govt. approved/recognized institute and should be medically fit.

Duration Approx 20 days (including acclimatization period).

Timelines/Route First Trekking Expedition is planned to be conducted in Jul 2025. A trek of approx 40-45 kms will be covered in 4-6 days, including acclimatization period.

Equipment/kitting A suggested list of mountaineering equipment, tools and accessories required to be carried by each participant as individual or common/community items as part of group is as attached at Appendix 'A'.

Indemnity Bond All participants will submit indemnity per bond as Appendix 'B' attached along with the application.

Arrival and Expenditure Participants will arrive at Guwahati Railway station at their own arrangement/ expenses. Army representative will take over for further travels thereafter. No major expenditure is envisaged by the participants on accommodation and transport from Guwahati onwards. Reasonable expenditure will be incurred by participants on food which is likely to be approximately 7400/- per individual during 20 days. of transit and acclimatization period. Individuals may make payment at requisite places themselves. Participants will be dropped back at Guwahati.

Applications Application as per attached format at appendix 'C' duly filled in be sent to Director-IMF (director@indmount.org) by 30 Jun, 2025.

Selection Selection / screening will be done by IMF based on CV/credentials/fitness of individuals in outdoor activities. Individuals may be called at IMF for final selections. All participants should preferably have done Basic Mountaineering Course from any Govt. approved/recognized Institute like NIM, JIM, NIMAS, IIM and ABVMAS etc.
