A hearing of Admission Regulatory Committee (ARC) under the Chairmanship of Sh. S.N. Sahai, IAS (Retired) was held on 22nd August, 2025 (Friday) at 04:00 p.m. at Conference Hall, Room No. 216, Admin Block, Indira Gandhi Delhi Technical University for Women Campus, Kashmere Gate, Delhi-110006 to deliberate upon grievances/representations/complaints received from aspiring candidates/parents/other stakeholders.

At the outset, the Director (HE/TTE) extended a warm welcome to the Chairman and Members present and placed the Action Taken Report of the University with respect to the proceedings held on 29 July 2025 (received vide Dy. No. 2143 dated 22.08.2025 and the copy of Show Cause Notices (received in ARC vide Dy. No. 2135-37 dated 20.08.2025) issued by the GGSIPU to the Directors of ADGIPS, MAIMS, MAITS before the Committee Members.

Registrar (GGSIPU) informed that the Show Cause Notices have been issued to these institutes as per the directions of the Admission Regulatory Committee (ARC) in the previous hearing regarding complaints received from students pertaining to Management Quota (MQ)

admissions in these institutes. They have been instructed to submit their replies by 25.08.2025, after which further action shall be taken on the basis of their submissions. The Chairman (ARC) emphasized that strict action be taken against institutes found at fault otherwise ARC will take action as per the provisions of the DPCI Act, 2007.

Thereafter, with the Chair's approval, a Power Point Presentation outlining group-wise complaints was presented before the Committee Members.

Further to above, the following was also discussed: -

1. It was observed that many complaints forwarded by ARC to GGSIPU remained unreplied. The Director (HE/TTE) directed Registrar (GGSIPU) to ensure timely/same day responses to these complaints, emphasizing that delayed replies render them ineffective, particularly for admission-related matters.
2. Registrar (GGSIPU) informed the Committee that the admission process is often delayed because affiliated colleges are required to obtain a “No Objection Certificate (NOC)” from the Directorate of Higher Education (DHE) every academic year with respect to their sanctioned intake/seats. The Director (DHE) confirmed that such NOCs are indeed being issued annually by their Directorate for all colleges affiliated to GGSIPU.

The Chairman, ARC observed that this repetitive requirement creates an additional burden not only on the colleges but also on the University as well as the DHE, and it delays the timely completion of the admission schedule. Accordingly, the Chairman requested the Director (DHE) to examine whether the current system of obtaining an annual NOC could be changed. Specifically, the suggestion is that once an NOC/approval is granted for a college or continuation of intake, it should remain valid for subsequent academic sessions unless there is a substantive change (such as increase/decrease of intake, addition/closure of course, or major deficiency in infrastructure/faculty).

In such a system, the requirement of applying for an NOC every year would be dispensed with, thereby reducing administrative burden and ensuring smoother admissions. Registrar (GGSIPU) also supported this proposal, noting that this would significantly save time and improve efficiency.

The Director (DHE) and Registrar (GGSIPU) agreed to consider the feasibility of this suggestion, and, if found workable and consistent with the governing regulations, a formal proposal for modification of the process may be initiated by the Registrar (GGSIPU).

3. The Director (DHE) observed that a significant number of complaints received pertain to the delay in refund of fees by affiliated colleges/university.

She emphasized that in many cases, students seek admission elsewhere, or in some cases, they do not continue their studies at the institution due to financial constraints. Therefore, timely refund of fees is essential so that students are not put to hardship.

The Director (DHE) accordingly directed Registrar (GGSIPU) to ensure that the process of refund of fees is treated on priority. Refunds should be initiated and completed at the earliest possible time frame, strictly in accordance with the UGC guidelines i.e. within 15 days of receipt of request for refund from a student.

4. Director (DHE) requested the Chairman (ARC) to consider holding of weekly meetings during the active admission season to redress grievances timely and effectively, which Chairman (ARC) agreed.

The meeting ended with vote of thanks to the Chair.
