Important Points:

Offline Counseling Procedure

Candidates shall please refer to the Chapter 8: 'Offline Counseling Procedure' Part-A, Admission Brochure 2025-26.

- 1. The spot round of offline counseling will be held after the completion of 2^{nd} counseling.
- 2. The vacant seats left after admission of candidates only shall be considered for filling in the spot counseling.
- 3. The conversion of vacant seats reserved for SC,ST,OBC etc. to General category shall be
- done only after the completion of 2nd counseling for the reserved categories
- 4. All eligible candidates desirous of participating in the spot counseling shall have to pay a counseling (separate) participation fee of Spot counseling. The participation fee in the 'Spot Counselling' shall be 500/- INR (non-refundable).
- 5. Any CET qualified candidates who have not taken admission in the previous counseling rounds will be eligible to participate in the spot counseling, against the available vacant seat (if any).
- 6. All "not admitted" candidates will be eligible to participate in the Spot Counselling.
- The conversion of seats reserved for SC, ST, and OBC to General Category shall be done only after the completion of 2nd counseling for the reserved categories.
- 8. Allotment of Seats will stop as and when the seats get filled up.
- 9. Eligibility Criteria for Programme- Master of Science (Microbiology) CET Code 414.

Graduation in Sciences (B.Sc/B.Tech/B.Pharm) Degree with at least 50% marks in aggregate. **10. Fee**

- d) Filled Admission verification form as per Appendix 6 of Part F of Admission Brochure 2025-26.
- e) Filled Preference sheet as per Appendix 11A of Part F of Admission Brochure 2025-26.
- f) Proof of date of birth (Secondary School Mark-sheet & Certificate) (Original and Photocopy)
- g) <u>Mark-sheets / Certificates of qualifying examination</u>: The candidate will be required to bring the Original certificates/Mark-sheets of all the year wise or semester wise in original along with photocopy of Certificates/ Marksheets of qualifying examination.
- h) For Distance / Open Learning Cases: In case of students who have passed the qualifying examination through distance / open education system of any recognized University / Board / Institution, the necessary documentary evidence related to location of his / her study centre i.e. study centre proof, certificate from the University imparting open / distance education certifying the location of the study centre to be submitted.
- i) <u>Physical Fitness Certificate</u>: All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate in given in Part-F in Admission Brochure 2025-26 (As per Appendix 5).
 - j) <u>Result Awaited</u>: candidates seeking admission as result awaited candidate must have to submit Appendix 4 of Part F of Admission Brochure 2025-2026.
 - k) Conduct and Character Certificate in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, not more than 06 (six) months old.
 - 1) Application regarding age relaxation with necessary approval shall be submitted on or before **11.07.2025**.
- 2. It will also be the sole responsibility of the candidates themselves to make sure that they are eligible and fulfill all the conditions prescribed for admission. Before filling-up the verification slip at the time of verification of documents/counseling/allotment of seats, candidate should ensure that he/she fulfils all eligibility conditions as laid down in the respective Admission Brochure for the session 2025-26. If it is found at any stage during the entire period of the programme that the candidate does not fulfill the requisite eligibility conditions, his/her admission will be cancelled and also disciplinary action will be initiated against his/her and entire fee will also be forfeited.
