IMPORTANT NOTIFICATION FOR OPENING OF CORRECTION / EDIT WINDOW IN PARALLEL TO CHOICE FILLING : MBA (CAT) CODE 101

Special Attention: Candidates seeking admissions against the seats reserved for Defence Category

1. This is in continuation to University's Important Notification No. 26/2025, IPU-7/DI(Academic)/Online Counseling/2025/448 dated 07.05.2025 regarding Commencement of Choice Filling & Allotment of seats for admission in programme Master of Business Administration (MBA) through CAT 2024 for Academic Session 2025-26.
2. It has been observed that while filling up of Online Application Forms, some of candidates have opted ONLY Armed Forces (Indian Army, Indian Navy, Indian Air Force), AND HAVE CHOSEN the Sub Category Defence as "NO". It is stated that such candidates will not be considered for seats reserved for Defence Category.
3. It is reiterated, to claim reservation of Defence Category Seat for admission in Programmes MBA through CAT 2024, Candidates are required to mark their Sub Category Defence "YES", Otherwise candidature of aforesaid candidates, who have marked their sub category Defence "NO" will be treated as "General Category Candidate" or "UR" for allotment of seat in Programmes MBA through CAT 2024 for Academic Session 2025-26, OR; they will be considered on merit Only in the college where the seats for Army, Indian Navy or Indian Air Force (specifically) exist. Further, the candidates choosing Defence Category are required to select the 'priority' of Defence they belong to and upload the desired valid appendices / documents.
4. It is to inform to all the stakeholders that the Correction/ edit window shall be opened from 14.05.2025 (03:00 p.m.) to 20.05.2025 (11:00 p.m.) for carrying out such corrections in parallel to the option of Choice/ Preference filling of Colleges/ Stream.
