**Subject:-** Schedule of Counselling in respect of B.Tech. Programme (Programme Code 131) for filling up 10% Management Quota Seats with the same procedure as followed for 90% seats, consequent to the pronouncement of Judgement on 12.09.2025 by the Hon'ble High Court of Delhi in LPA 466/2023 & CM APPL. 44949/2025 titled Surajmal Memorial Education Society & Anr. Versus Govt. of NCT of Delhi and to comply the Judgement dated 17.05.2023 in WP (C) No. 2368/2023 & CM APPL. 9063/2023 Ishika Deswal and Ors. Versus MAHARAJA SURAJMAL INSTITUTE OF TECHNOLOGY, GGSIP University and other connecting matters.

1. Pursuant to Judgement Pronounced on 12.09.2025 by the Hon'ble High Court of Delhi in LPA 466/2023 & CM APPL. 44949/2025 titled Surajmal Memorial Education Society & Anr. Versus Govt. of NCT of Delhi and Ors. dismissing the said appeal, the directions issued vide order dated 17.06.2023 by the Hon'ble Single Bench in WP (C) 14677/2022 & CM APPLs. 44985/2022, 45790/2022, 45791/2022, 56595/2022, 56596/2022 & CM APPL. 4910/2023..... WP (C) No. 2368/2023 & CM APPL. 9063/2023 **Ishika Deswal and Ors. Versus MAHARAJA SURAJMAL INSTITUTE OF TECHNOLOGY, GGSIP University and other connecting matters**, are being complied with, wherein it was held in Para 183 of the said judgement as under:

***Para 183. Hence, instead of treating the admissions made in the Academic Session 2022-23 as null and void, the 10% Management Quota Seats of the MSIT for the Academic Session 2023-24 stands reduced the Nil, meaning thereby that the 10% Management Quota Seats shall be filled up by the designated Authority as per the procedure to be followed for filling up the remaining 90% seats for the Academic Session 2023-24, Any advertisement, already issued by MSIT, for admitting students against the 10% Management Quota seats stands cancelled.***

3. The order of dismissal of LPA no. 466/2023 & CM APPL. 44949/2025 titled Surajmal Memorial Education Society & Anr. Versus Govt. of NCT of Delhi and Ors. has been pronounced on 12.09.2025, and the last date for admission in the B. Tech. course is 15.09.2025 as directed by the Hon'ble Supreme Court of India. In view of paucity of time and in the exceptional circumstances to comply the Judgement dated 17.05.2023 and subsequent Judgement dated 12.09.2025 and considering that the counselling is already in the advanced stage, all the regular Rounds of Online Counselling and Online Spot Round has already been over and the last date of Special Round of Offline Counselling is getting over on 14.09.2025 and the deadline for AICTE governed courses is 15.09.2025, classes having begun on 1<sup>st</sup> of August 2025, the Competent Authority has approved to fill up the 10% Management Quota Seats of MSIT as per the following procedure which will be in continuity of the procedure being followed for the Special Round of Offline Counselling for the Academic Session 2025-26 in respect of B.Tech. Programme (131) notified vide Notification No. 281/2025; IPU-7/DI(Academic)/Offline Counselling/2025/1241 dated 26.08.2025.

### IMPORTANT INSTRUCTIONS/GUIDELINES

1. To ensure that the already concluded admissions are not disturbed, this special Round of Offline Counselling will be conducted only for **"NOT ADMITTED"** candidates in the programme B.Tech. The aspiring candidates should not be in possession of a seat as on 14.09.2025 in B.Tech. Programme (131) in GGSIP University (**USS/Affiliated Institutions**). The candidates who have taken admission in the B.Tech. Programme during **ONLINE AND SPECIAL ROUND OF OFFLINE COUNSELLING AND HAVING STATUS "ADMITTED" FOR THE ACADEMIC SESSION 2025-26 through JEE MAINS PAPER-I (NLT EXAM)** in respect of BTECH Programmes for the Academic Session 2025-26 shall not be eligible in this Special Round of Offline Counselling. Candidates who have already taken admission in the Management Quota in affiliated Institute/College shall not be eligible in the Special Round of Offline Counselling.
2. During this special Round of OFFLINE Counselling, the University shall ensure that allotment of seats in respective programme in MSIT is purely on merit basis and in accordance with CAPPING/CUTOFF determined through Online Counselling of the respective programmes/stream of MSIT to ensure NO rank violation with respect to admitted candidates as prescribed in The Delhi Professional colleges or institutions (prohibition of Capitation Fee, Regulation of Admission, Fixation of Non -Expolitative Fee and Excellence) Rules . For CAPPING/CUT OFF, candidates are advised to visit University website, the same are available on the University website.
3. During the course of this Special Round of Offline Counselling, the allotment of seats shall be carried out irrespective of region and category and on All India basis.
4. The conduct of this Special Round of OFFLINE Counselling is to comply with the directions of the Hon'ble Court and in the interest of students and institute.
5. **Physical presence of the candidate is mandatory at the time of Offline Counselling, except for medical reasons.**
6. Stream once allotted in this Round of Counselling will not be changed subsequently.
7. The candidates are advised to ascertain their eligibility and particularly CUT OFF/Capping before attending counselling.
8. It will also be the sole responsibility of the candidate to ascertain and make sure that he/she possesses the requisite eligibility and qualifications prescribed for admission in the course.
9. The Allotment of seats will be carried out on the basis of the CRL/Rank in JEE MAINS PAPER I 2025 and not on the basis of the aggregate marks obtained at the qualifying examination.

11. Document required at the time SPECIAL ROUND OF OFFLINE Counselling are as under:-

a. Candidates who have not registered earlier for B TECH PROGRAMME CODE 131 on NIC portal are required to bring DD of Rs.2,500/- Application Fee (Non Refundable) in favour of Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi.



- b. In addition to above Bank Draft(s) of Rs. 96,000/- towards part academic fee is required, which is mandatory at the time of counselling in favour of Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi. The candidate will write his name, date of admission, phone, address, mobile no, name of the programme, CET Rank and CET Application Number on the back of the Bank Draft(s). Balance fee (if applicable) shall be paid by the candidate at the allotted institute.
- c. Those candidates who will not be able to bring Demand Draft as per the details above shall be allowed to deposit fee through online mode.
- d. NOTE: THE FEE OF Rs. 96000/- IF PAID DURING THE COURSE OF ONLINE COUNSELLING PROCESS SHALL NOT BE ADJUSTED DURING THIS ROUND. THE FEE PAID EARLIER WILL BE REFUNDED SEPARATELY. HENCE, IT IS MANDATORY TO BRING THE DEMAND DRAFT FOR OBTAINING SEAT IN THIS ROUND OF COUNSELLING.

- o. Conduct and Character Certificate in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, not more than 06 (six) months old.






