I. At the commencement of the hearing, Registrar (GGSIPU) apprised the Committee of the following: -

- a. The University has made refunds to approximately 7,500 students since the last ARC hearing held on September 18, 2025.
- b. Pursuant to the directions issued during the last ARC hearing regarding Show Cause Notices to various institutes issued by the GGSIPU and various complaints on Management Quota

Admissions, an Inquiry Committee has been constituted under the Chairmanship of Sh. S.P. Singh, IAS (Retired) to conduct a thorough inquiry into the complaints against MAIMS, MAIT, ADGIPS and BPIT for the Academic Session 2025-26. The Inquiry Committee was initially given two days to examine the issues and arrive at conclusions but the Committee has requested an extension of at least 10 days for a comprehensive examination.

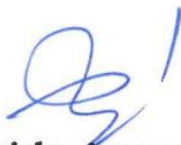
