The Member Secretary welcomed all present in the meeting. After the quorum was complete, meeting began.. He informed that the Cell has been working on many activities and initiatives with the cooperation of all. Some of these are: Silver Jubilee celebrations culmination and felicitation of employees for their contributions and loyalty, setting up of Off-Shore campus at Guyana, Dual Degree Programmes with AGH University Poland, Strategic Plan for 2047, Setting up of Robotics Lab, TV Studio, Radio Station, Bank and Transit Hostel at East Delhi Campus, enhancement of rain water harvesting capacity, open air amphitheatre, Guest House and Faculty Hub, Indoor Sports Complex, etc. In addition, organizing the Smart Delhi Ideathon was appreciated by all and complimented the Vice Chancellor for the support and guidance.

Prof. Mahesh Verma, Vice Chancellor welcomed all the members to the meeting. He thanked all for their support and cooperation for effective quality initiatives in the University. He

reiterated the commitment of the University towards quality processes and assured support in all such quality endeavours.

Agenda -1: To approve the minutes of last meeting.

Minutes were circulated to all the members by email and since no comments have been received the Minutes were deemed to be confirmed.

Agenda-2: To review the Action Taken Report for the points emerging from last meeting.

The Action Taken Report for the points emerging from the last meeting was circulated to all members through email. The report was read point wise and Members were apprised of the same. The members appreciated the progress on the actions for the discussions held in last meeting on 28.5.2024.(copy attached as Annexure –A).

Agenda-3: To apprise the members about status of submission of AQAR 2023-24.

It was informed that the AQAR for the year 2023-24 was submitted to NAAC in time in respect of 13 University School of Studies including the East Delhi Campus. The University is awaiting its formal approval since no more comments have been received so far from NAAC.

It was informed that process to collect the required data for the AQAR of 2024-25 shall be started soon.

Agenda-4: To apprise the members about the filing of NIRF Data and Other Rankings

Member Secretary apprised the Members that the University has submitted the data for NIRF Ranking 2025. The university like last years is participating in the disciplines of Management, Engineering, Architecture and Law as well as Categories of University, Research, Innovation and Overall. The results are expected in June 2025.

It was informed that University has been receiving communication from many ranking agencies in the country. It was discussed and decided that University should submit data only for reputed ranking only. The MDRA India Today Group approached for filling the data for B-Schools and Architecture as per their template. The same was filled and submitted for ranking purpose. In addition, the MDRA India Today University Ranking data is to be filled in by 23rd April 2025. The data filling is in process.

It was informed that School of Management of GGSIPU has been ranked at 38 in the Top MBA Colleges in India 2025 survey conducted by Indian Institutional Ranking Framework (IIRF).

Agenda-5: Update on NBA Accreditation for eligible programmes

Prof. Pushpinder Singh Bharti, Project Director, NBA Cell briefed the members about the progress of the NBA Accreditation for various programmes. He informed that the data has been captured and tested for Pre-Qualifier status. There are certain deficiencies observed which shall be taken up with the Registrar.

It was requested by Member Secretary to Prof. Dharminder that he may kindly help the University in preparations for the NBA. Prof Dharminder agreed to extend his time and support for handling the NBA accreditation process. Member secretary expressed his gratitude for the assurance.

Agenda-6: Status Update on Academic Audit of Affiliated Colleges and USS.

It was informed that the Academic Audit is an annual exercise assigned to IQAC Cell by the NAAC. The academic audit for the year 2023-24 has been completed in the month of January 2025. This was carried out with the help of our Internal Convenors and one external expert. The proforma used in the audit was an improved version overcoming the difficulties and the objectivity issues faced in the previous years.

Further it was informed that audit performa for Health and Medical related programmes still need to be worked out. It was mainly on account of the change of Dean of the School of Medical and Allied Health Sciences. It was promised to modify the performa at the earliest. In addition, it was shared that the performa for the USS is in the final stages and shall be used to carry out the Academic Audit of the USS.

Agenda-7: New Welfare Initiatives – Day Care Centre at East Delhi Campus. Transit Accommodation at EDC.

The members were briefed about the various new initiatives of the University:

- a. One seat reserved for Single Girl Child – One supernumerary seat per UG/PG Programmes at University School of Studies only wef academic session 2024-25. In case regulatory body of any programme has imposed any restrictions to it, the one seat would be taken from the sanctioned intake. The seat would be allocated on All India basis without any regional or category allocation.
- b. Introduction of maximum of 2% sports quota per programme in the University School of Studies and Centres w.e.f. 2024-25.
- c. Transit Teacher Hostel has been made operational at East Delhi Campus.
- d. New State of the art TV Studio has been setup at East Delhi Centre
- e. The work has been initiated and approval obtained for launching the Community Radio Station at East Delhi Campus.

MOU have been signed by the University with:

- Yuri Gagarin State Technical University of Saratov, Russia
- Novosibirsk State University of Economics and Management, Russia
- AGH University Poland for Dual Degree Programs
- St. Petersburg University, Russia has been approved but yet to be signed.

It was informed that IQAC Cell is working on the proposals to organise workshop/seminar on Issues and Challenges for Quality awareness in HEIs.

Agenda-8: Regarding the Renewal of ISO Certification.


It was informed that the ISO Certification expired in December 2024. The certification process was carried out and the valid ISO Certification has been obtained valid for 3 years subject to satisfactory surveillance visits. This time the Schools of East Delhi Campus have also been included. Members appreciated the efforts put in this regard.

Agenda-9: Any other agenda with the permission of the Chair.

Suggestion was made to display the consolidated list of authorized hospitals/diagnostic centres on the University website. At present, the names of hospitals are uploaded as and when the hospitals are empanelled. If list is made available in a consolidated form for quick referral by the employees at the time of need, shall be highly useful for the employees. All members accepted the proposal.

There being no other point raised, the meeting ended with a vote of thanks to the Chair.
