INVITING PHYSICAL APPLICATIONS FOR 04 SEATS OF MD (PAEDIATRICS) IN CHACHA NEHRU BAL CHIKITSALAYA UNDER GGSIPU STATE/ INSTITUTIONAL QUOTA

All the concerned candidates eligible for admissions/allotment of seat under GGSIPU State/ Institutional Quota seats are hereby informed that the admission in 04 Sate Quota seats of MD (Paediatrics) in CHACHA NEHRU BAL CHIKITSALAYA, Raja Ram Kohli Marg. Geeta Colony, New Delhi, for the session 2025-26, shall be carried out by the Guru Gobind Singh Indraprastha University, New Delhi in offline/physical mode in the University Dwarka Campus, New Delhi, for the following Categories under 200 point Roster:-

Eligibility: Only candidates who have obtained their MBBS degree from the affiliated medical colleges of Guru Gobind Singh Indraprastha University, New Delhi are eligible for admission to the state/ Institutional quota seats.

Every candidate selected for admission to PGMC shall posses MBBS degree recognized by Medical Council of India and must have completed one year compulsory rotatory internship on or before Specified date of the admission year. The candidate should have obtained permanent registration with the MCI or any of the State Medical College. Only candidates who have obtained their MBBS degree from the Guru Gobind Singh Indraprastha University, New Delhi are eligible for admissions to the State/ Institutional quota seats.

Admission Criteria: All candidates must have appeared in the National Eligibility cum Entrance Test Postgraduate of 2025 (NEET PG 2025) and qualify to be considered for admission.

All the concerned eligible candidates desirous of seeking admission in MD (Paediatrics) at Chacha Nehru Bal Chikitsalaya against seats reserved for State/Institutional Quota must submit physical copy of application duly filled with particulars as sated below for participation in Offline Counselling for allotment of seat.

→ **The application duly filled with complete particulars must be submitted at Facilitation Centre of Guru Gobind Singh Indraprastha University. Sector- 16C, Dwarka, New Delhi w.e.f. 20.11.2025 (Thursday 11:00 AM) till 21.11.2025 (Friday upto 04.00 PM) along with the documents as stated below:-**

1. Application request stating:

 - iv) DOB- enclose self attested photocopy of class X marksheet
 - v) Address of correspondence

- vi) Category (UR/SC/ST/OBC/EWS) - enclose self attested photocopy of relevant certificate.
vii) Qualification (with name of the Institute and Year of Passing)
viii) NEET PG 2025 Roll Number & All India NEET PG 2025 Rank.
ix) Self Attested photocopy of NEET PG 2025 Rank Card.
2. Demand Draft of Rs. 2,500/- (Non-Refundable Registration Fee) in favour of Registrar, GGSIPU, payable at New Delhi.
 3. Self Attested photocopy of MBBS degree (only from affiliated medical colleges of GGSIPU).
 4. Self Attested photocopy of One year Compulsory rotatory internship certificate.
 5. Self Attested photocopy of permanent registration with the MCI or any other State Medical Council.

→ The envelope containing duly filled application for participation in counselling process for allotment of seat in MD (Paediatrics) against State/ Institutional Quota should be addressed to Director Incharge (Academic), Guru Gobind Singh Indraprastha University, Sector 16C, Dwarka, New Delhi. All desirous and eligible applicants need to submit their applications at the Facilitation Centre, O/o PRO, GGSIPU within the notified date and time. Applicants in their own interests are advised to obtain proper receipt for having submitted application. The candidates failing to submit duly filled application along with required particulars in the laid down time shall not be considered for participation in the counseling process for allotment of seat.

→ The list of candidates having submitted duly filled application at the Facilitation Centre shall uploaded on University website on 24.11.2025 for information and the candidates may submit observation, if any, in the list on 25.11.2025 (upto 12:00 noon).

→ The tentative date of conduct of Round 01 Offline Counselling for the seats under GGSIPU State/ Institutional Quota is 26.11.2025. The detailed counselling procedure containing instructions and information such as date, time, venue, demand draft and documents required at the time of counselling/ allotment of seat shall be notified on 25.11.2025.

Any change in reservation policy, if taken by the Government of India/NCT of Delhi or the University, the counseling will be conducted in accordance to that.

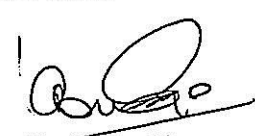
All counseling shall be held according to the directions of the Statutory Government of India/ NCT Delhi, Hon'ble Court(s) and/ or the University.
