Subject: Schedule and Instructions for participation in the 20th GGSIPU Inter-Collegiate Kabaddi Championship

The 20th GGSIPU Inter-Collegiate Kabaddi Championship is scheduled to be held from 29th October to 3rd November 2025 at the University Kabaddi Court, Dwarka Campus, as per the fixture attached.

Instructions:

1. All teams must submit the Eligibility Proforma (Annexure-2), duly filled and signed by the Principal/Director, along with a photocopy of the identity card of all players, at the venue at least one hour before the scheduled time of their match. All columns of the Eligibility Proforma must be properly filled, and no team will be allowed to participate without the Eligibility Proforma under any circumstances.
2. All participants must produce their original College/Institute Identity Card at the time of registration/competition or whenever required by the officials.

Rules:

1. Players must report in proper sports kit at least 30 minutes before the scheduled time of their match.
2. Walkover will be given to the opponent if a team fails to report at the scheduled time.
3. Each Institute may field a maximum of one Men's and one Women's team. Each team may consist of a minimum 7 and maximum of 12 players.
4. Weight limit: Each player's weight shall be below 85 kg (Men) and below 75 kg (Women).
5. Matches will be played on a Mud Court. Players will be allowed to play barefoot or wearing mat shoes only.
6. Participants will not be permitted to wear rings, bracelets, chains, or any other ornaments during the match.
7. Matches up to quarterfinals will be played 15-5-15 minutes. Semi-final and finals will be played of 20-5-20 minutes.
8. The Referee/Umpire's decision shall be final and binding on all participants.
9. All participating players and team officials must adhere to the Rules and Regulations notified vide Notice F. No. 36(2)(1)/2024/DSW dated 29.09.2025.

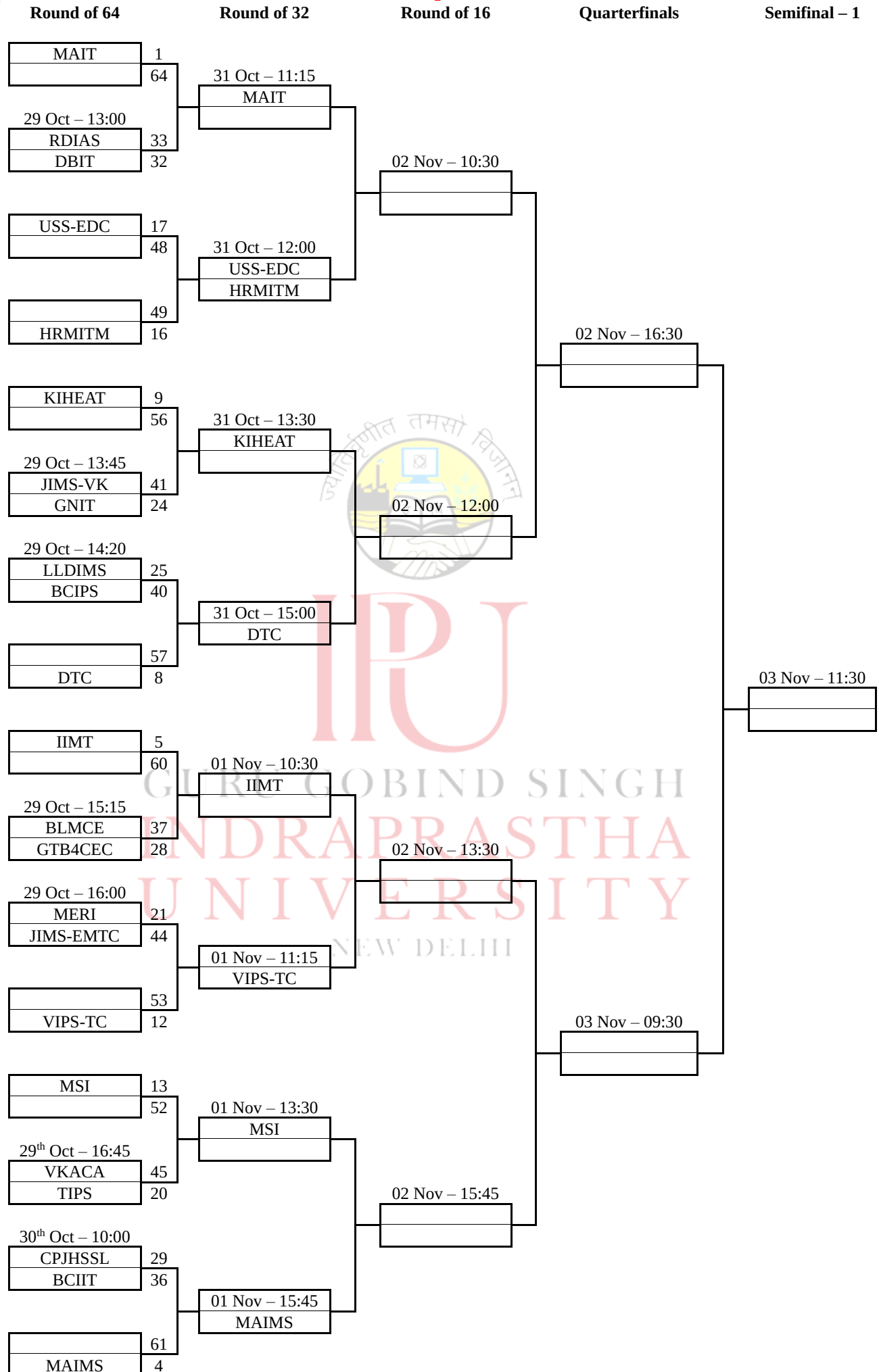

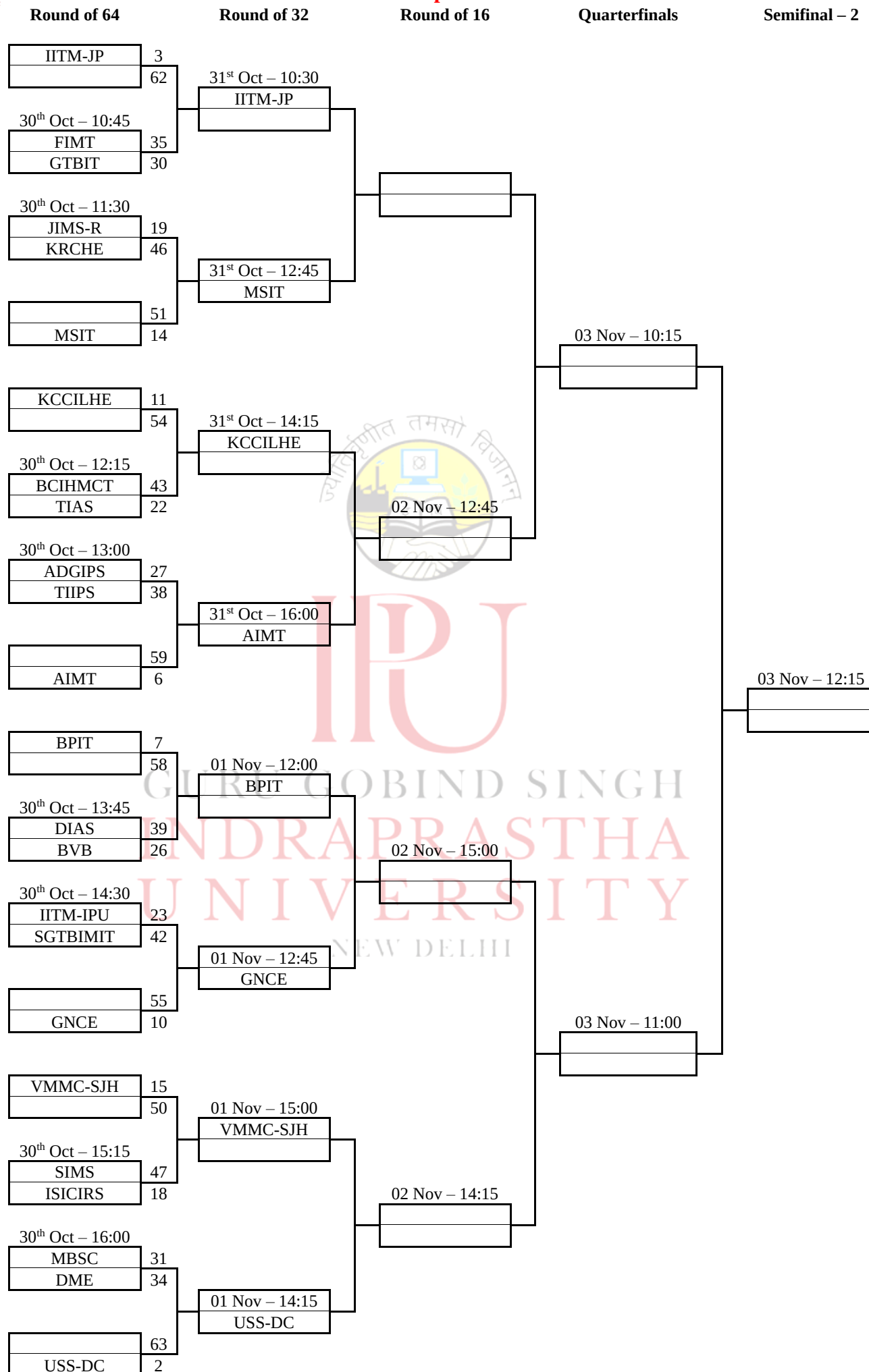

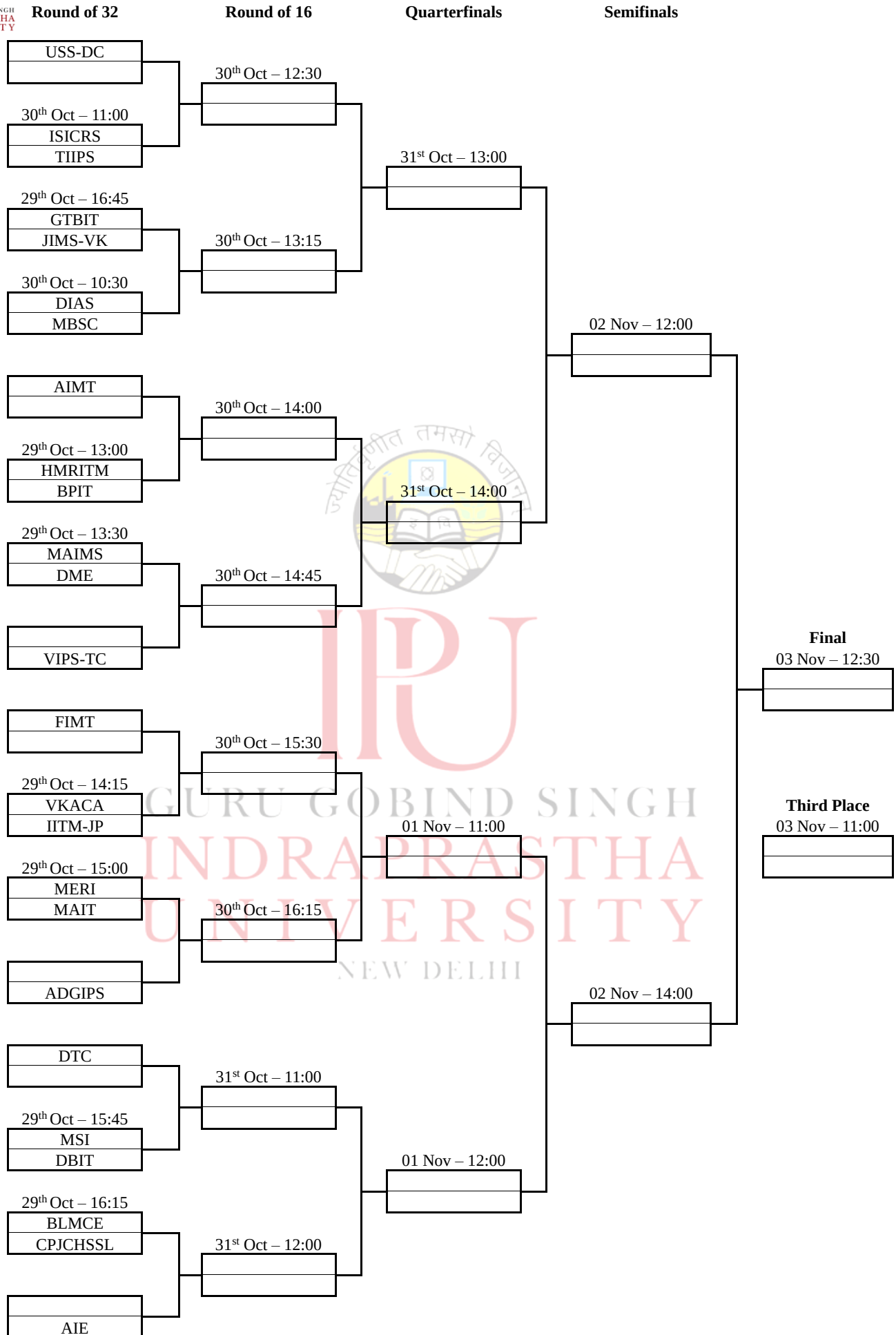
