CIRCULAR

Subject: Stray Dog Management and Safety Measures within the University Campus

In continuation of Circular No. IPU/SS/2020-21/SD/1739 dated 12th September 2023, it has been observed that the population of stray dogs within the University premises has been increasing. Several incidents of dog bites have also been reported, raising concerns regarding the safety of students, staff, residents, and visitors.

To address this situation effectively and in compliance with the Animal Birth Control (Dogs) Rules and relevant provisions under the Animal Welfare Act, the following measures shall be implemented:

1. Vaccination and Sterilization of Stray Dogs

- All stray dogs on campus shall be sterilized and vaccinated by the Municipal Corporation of Delhi (MCD), Najafgarh Zone.
- Sh. Sunil Kumar, Assistant Registrar (Horticulture) will coordinate with MCD officials to ensure timely and proper execution of the sterilization and vaccination drive.

2. Designated Dog Feeding Spots

Feeding of stray dogs is allowed only at the following designated spots:

- Near STP/Horticulture Area
- Behind Hostels
- Near Staff Quarter Type-III

* Proper signage and hoardings will be installed at each designated feeding spot.

The deployed security guards of the University shall ensure that feeding of stray dogs is carried out strictly at the designated dog feeding spots. Any non-compliance in this regard should be reported to the Estate Branch along with relevant photographs as evidence.

3. Prohibited Feeding Items

- Feeding sweets or sugary items to stray dogs is strictly prohibited to prevent health complications, as advised by the Dy. Director (Veterinary Services), MCD, Najafgarh Zone.

4. Identification of Dogs

- Dogs not yet sterilized/vaccinated shall be marked with a loose red bandage tied around the neck.
- Dogs already sterilized/vaccinated shall be marked with a loose green bandage.
- Bandages must be of good quality and securely tied. This marking process will be overseen by Sh. Sunil Kumar, Asstt. Registrar (Horticulture) in coordination with MCD.

5. Installation of Coyote Rollers

- Coyote Rollers will be installed on all University Gates to prevent entry of stray dogs from outside.

6. Security and Patrolling

- The Security Agency shall ensure no entry of stray dogs from outside the University premises.
- A special patrolling team (4:00 PM to 11:00 PM) shall be formed. This team will consist of guards equipped with. Whistles / batons to take prompt action to ensure safety and prevent any dog -related incidents on campus taking due care that no cruelty or harm is made against any animal.

7. Responsibilities of Campus Residents

As per MCD guidelines, all campus residents are requested to ensure:-

- Leashing and Muzzling of their pets whenever in open.
- Registration: All pet dogs must be registered with the Municipal Corporation of Delhi.

8. Sh. Sunil Kumar Assistant Registrar, Horticulture Nodal Officer will coordinate with the Dy. Director(Veterinary Services), MCD, Najafgarh Zone, to ensure sterilization & vaccination of the stray dogs in the Campus, including steps to procure Dog Band / collar for identification & complete action.
