Instructions:

- 1. All teams must submit the Eligibility Proforma (Annexure-2), duly filled and signed by the Principal/Director, along with a photocopy of the identity card of all players, at the venue at least one hour before the scheduled time of their match. All columns of the Eligibility Proforma must be properly filled, and no team will be allowed to participate without the Eligibility Proforma under any circumstances.
- 2. All participants must produce their original College/Institute Identity Card at the time of registration/competition or whenever required by the officials.

Rules:

- 1. Each Institute may send 7 entries for each men's and women's competition.
- 2. Chest No. will only be issued to the participants on submission of their Eligibility Proforma (Annexure-2) duly filled and signed by the Principal/Director and photocopy of identity card of all team players at the venue an hour before scheduled time for registration of the team. All columns of the eligibility proforma must be filled properly.
- 3. Only first three positions in both Men & Women will be awarded.
- 4. The race will be of 5km for both men's and women's.
- 5. The Referee/Umpire's decision shall be final and binding on all participants.
- 6. All participating players and team officials must adhere to the Rules and Regulations notified vide Notice F. No. 36(2)(1)/2024/DSW dated 29.09.2025.
