**MANDATORY UPLOADING of Educational Testimonials and Reserved Category Documents and Opening of Correction Window: Academic Session 2025-26**

1. Reference University's Notification No. 25/2025, F.No. GGSIPU/DI(Academic)/ Misc/2025/440 dated 07.05.2025 informing that the seats will be allotted on the claimed Category/ Region initially; subsequent verification of documents uploaded by the candidates, towards their claim of seat, will be carried out after allotment of online rounds of counselling.
2. The results of Common Entrance Tests have been declared for the above mentioned programmes and are available on the University Website. All the CET Qualified Candidates, who have obtained a rank in CML, shall be treated as participating candidates in the Centralized Online Counselling for the above courses.
3. In view of this, it becomes imperative that all the candidates participating in Counselling, filling up Choices / Preferences of Colleges / Streams, SHOULD FILL THE CORRECT DETAILS PERTAINING TO THEIR REGION / CATEGORY.
4. It is the sole responsibility of the candidate to ensure that they fulfill the minimum eligibility criteria in the programmes they seek admission; the correctness of the details filled with respect to Region; Category or any other such details for allotment of seat. If at any stage of admission procedure the information furnished by the candidate is found to be incorrect or untrue the admission to the programme shall be cancelled and the fees will be forfeited. Appearing for the written examination / applying for admissions does not necessarily mean acceptance of eligibility.
5. Since the result of Class 12<sup>th</sup>/Qualifying Exam has been declared, ALL THE CANDIDATES WHO HAVE APPARED IN COMMON ENTRANCE TEST MUST

UPLOAD THE MARKSHEET OF THEIR CLASS 12 / QUALIFYING EXAMINATION, for ascertaining the eligibility of their securing a seat. ALSO it is mandatory to upload the valid Reserved Category Certificates towards their claim of seat. In the absence of valid / correct documents, the seat so secured on the basis of claimed Category / Region shall be jeopardized.

6. With regard to Result Awaited candidates, it is made clear that who have **compartment as on this date in his qualifying examination will not be considered for admission. They should seek provisional admission only due to non declaration of result of final year/final semester of the qualifying examination by Board/University and not on account of compartment in current or previous years of qualifying degree examination as on date of admission.** Result Awaited candidates may please see the provisions contained in **Chapter 3 of Part A** and Appendix-4 of Admission Brochure for Bachelors Programme).
7. Candidates are advised to re-check and/or correct/ edit their filled application form specifically their Category, Sub-Category and Region (as per Last Qualifying Examination) for allotment of seat in their claimed Region/ Category/ Sub-Category.
8. It is reiterated, to claim reservation of Defence Category Seat for admission above programmes, Candidates are required to mark their Sub Category Defence "YES", Otherwise candidature of aforesaid candidates, who have marked their sub category Defence "NO" will be treated as "General Category Candidate" or "UR" for allotment of seat for Academic Session 2025-26, OR; they will be considered on merit Only in the college where the seats for Army, Indian Navy or Indian Air Force (specifically) exist. Further, the candidates choosing Defence Category are required to select the 'priority' of Defence they belong to and upload the desired valid appendices / documents.
9. To achieve above objective, a Window for uploading of testimonials /certificates shall be opened alongwith Correction Window (for carrying out certain corrections). The date of opening of this window will be notified in due course of time.
