PROCEEDINGS OF THE HEARING No. XV

A hearing of Admission Regulatory Committee (ARC) under the Chairmanship of Sh. S.N. Sahai, IAS (Retired) was held on 29th July, 2025 at 04:30 p.m. at Conference Hall, Room No. 216, Admin Block, Indira Gandhi Delhi Technical University for Women, Kashmere Gate, Delhi-110006 to deliberate upon grievances/representations/complaints received from aspiring candidates/parents/other stakeholders.

At the outset, the VC, IGDTUW extended a warm welcome to the Chairman and Members present. In the beginning, the Prof. Udayan Ghose gave the following updates on the ongoing Admission Process for the year 2025-26:-

- **Admissions:** Over 23,000 admissions have been made so far.

- **Offline Counselling:** Offline counselling for standalone programs has been completed.
- **Reporting at Allotted Institutions:** Candidates who have been allotted institutions need to report on July 30 and 31, 2025.
- **Online Spot Rounds:** Online spot rounds are scheduled to start from August 4 or 5, 2025.
- **Online Sliding Round Results:** The results for 12 programs will be published on July 29, 2025.

The Committee Members appreciated their efforts in ensuring a smooth admission process. Thereafter, with the Chair's approval, a Power Point presentation outlining group-wise complaints was presented before the Committee. The Action Taken Report (ATR) was also presented to the Committee Members by GGSIPU officials.

The Chairman underscored that many students face financial or logistical challenges, and a reasonable window for fee payment is both practical and compassionate.</p>

The Committee observed that complaints have been received regarding the challenges faced by aspiring Management Quota (MQ) students in accessing application forms via the official websites of Maharaja Agrasen Institute of Management Studies (MAIMS), Maharaja Agrasen Institute of Technology (MAIT), and Dr. Akhilesh Dass Gupta Institute of Professional Studies (ADGIPS). The websites were reported to be slow, unresponsive, or plagued by technical glitches.

Despite earlier directions issued to GGSIPU in previous meetings to monitor and prevent such tactics, students continue to experience persistent difficulties - both in submitting forms online and obtaining them through offline means.

Taking the matter with utmost seriousness, GGSIPU has been instructed to address all such complaints with urgency. The Institutions not complying with the guidelines to be issued show cause notices and immediate and appropriate strict action must be initiated as per the extant rules/regulations.


