Sub: Security Measures During "Anugoonj 2026"

The Annual Cultural Festival "Anugoonj 2026" of the University is scheduled to be held from 04th to 06th February 2026 at Dwarka Campus of the University. In this regard, the following security arrangements have been made, in line with the decision taken in Security & Discipline Committee / pre-liasoning meeting with Delhi Police personnel for smooth functioning of the Cultural Festival "Anugoonj 2026".

- i. The usage of Gates for the entry shall be done in the following manner:

Gate No. 1 (Near PRO)	Only for Male students of the USS and Affiliated Colleges
Gate No. 2	Only for Female Students of USS and Affiliated Colleges Teaching and Non-teaching Staff of the University
- ii. Only the bonafide students of the University and its affiliated colleges/institutes shall be allowed to enter the University Campus only after verification of the ID card issued by the concerned USS/Centre/Institute/College, and in the absence of the above, no entry shall be allowed under any circumstances.
- iii. Entry for other outsiders will be strictly prohibited.
- iv. The programmes on each day shall conclude by **05:00 p.m.**
- v. Student vehicles, including 2/4 wheeler will not allowed inside or outside of the University campus and the students are advised to use public transport only. Any vehicle found parked on the service road/outside main road will be towed away by the Delhi Traffic Police.
- vi. No entry is allowed in the University Campus after 03:00 PM during Anugoonj – 2026 from 4th Feb to 6th Feb 2026. Thereafter all gates will be closed till the conclusion of the event.
- vii. All the students are not allowed to bring bags of any kind, however, girl students may carry a small hand bag with them. No weapon or alcohol or other prohibited substances shall be allowed in the University campus during the event. **Breath Analyzer Test of the suspected students may be conducted by Security Personnel/Delhi Police.**
- viii. Student found misbehaving with University staff, Security Personnel or students will be immediately removed by the discipline committee/Delhi Police/Security Personnel
- ix. All the students visiting the campus for the festival are required to avoid Hostel area and Residential Flat area as **"Out of Bounds"**.
- x. There shall be restricted entry to various academic blocks during Anugoonj-2026. The lift and other inter-blocks will be closed during Anugoonj-2026.
- xi. The entry of the students and visitors will be allowed only after frisking and security check under the supervision of Delhi Police personnel.
- xii. Washroom (Ground Floor only) of Block- A & B are earmarked for female students while Block -C & D are earmarked for male students & they can further use the mobile toilets kept at various location in the campus.
