4. Income Certificate issued by SDM, GNCT of Delhi- Attested by Gazetted officer
5. The student must have passed the previous Class. Certificate of last examination passed- Attested by Gazetted officer
6. Certificate from Competent Authority in case of Hosteller student
7. Certificate of recognition/affiliation of Private College/Institutes by Government be attached.
8. Certificate that the student concerned fulfills all the eligibility conditions advertisement published by Department for the Welfare of SC/ST/OBC.
9. Certificate to the effect to whom favour Cheques are required to be issued for disbursement of Post Matric Scholarship
10. Particulars of students may be submitted in CD in excel form.
11. Certificate by All Head of Colleges/Institutes mentioning that the students concerned are not getting any other scholarship/stipend. Students who have applied for Merit Scholarship are not eligible under scheme.
12. All the Principal/Head of College/Institutes may ensure & certify to this scheme that in case of professional course it is available to only those students who are admitted against 'free seats' whether in Govt. or private institutions & also in case of private Institutions where admission is on the basis of 12<sup>th</sup> standard examination marks, there shall be a bench mark of 60% for availing the scholarship.

All Head of Colleges/Institutes may also be informed that no individual application forms will be received from student concerned.
