### **IMPORTANT INFORMATION**

- (i) Students and their parents are advised, in their own interest, to visit the various Colleges/Institutes prior to the date of counseling to ascertain the location, other academic and infrastructural facilities available such as hostel, transportation etc. in the various Colleges/Institutes which may facilitate their decision-making at the time of counselling/admission. On the day of admission/counselling, the students will be required to take on the spot decision and no further time will be given to them.
- (ii) If it is found at any stage during the entire period of the programme that the candidate has furnished any false or incorrect information in the application form or at the time of counselling/admission, his/her candidature for the programme will be cancelled summarily. In addition, disciplinary action may be taken against him/her as per the University rules.
- (iii) If the University is not satisfied with the character, past behavior or antecedents of a candidate, it can refuse to admit him/her to any Programme of study of the University.
- (iv) The Vice Chancellor may cancel the admission of any student for specific reasons and debar him/her for a certain period.
- (v) Only qualifying the Common Entrance Test shall not, ipso facto, entitle a candidate to get admission to a programme.
- (vi) It will also be the sole responsibility of the candidates themselves to make sure that they are eligible and fulfill all the conditions prescribed for admission. Before filling up the verification slip at the time of counselling/ allotment of seats, candidate should ensure that he/she fulfills all eligibility conditions as laid down in this Admission Brochure. If it is found at any stage during the entire period of the programme that the candidate does not fulfill the requisite eligibility conditions his/her admission will be cancelled and also disciplinary action will be initiated against him/her and the entire fee will also be forfeited.
- (vii) The merit of the CET will be valid only for the programme for which the candidate has appeared and cannot be utilized for admission to any other programme. Further, the merit of the CET- 2026 shall be valid only for the academic session 2026-27.

No. DHE 18(1)/6th SFRC/2023/3205-15.**—Whereas, in exercise of powers conferred by sub-section (1) of section 6 of the Delhi Professional Colleges or Institutions (Prohibition of Capitation Fee, Regulation of Admission, Fixation of Non-Exploitative Fee and Other Measures to Ensure Equity and Excellence) Act, 2007 (Delhi Act 8 of 2007), the Lt. Governor of National Capital Territory of Delhi had constituted 6<sup>th</sup> State Fee Regulatory Committee vide Notification Number F.DHE F. No. DHE 18(1)/6<sup>th</sup> SFRC/2023/7697-7714 dated the 14<sup>th</sup> December, 2023 for the purpose of determining fee for pursuing courses in privately managed institutions offering different courses in the National Capital Territory of Delhi. Further, the Lt. Governor of National Capital Territory of Delhi has decided that the fee proposed by the State Fee Regulatory Committee be notified for the academic Year 2025 -26.

The fee for the academic year 2026-27 will automatically increase over the fee notified for the academic year 2025-26 in commensuration with the annual increase announced in the whole sale price index of Govt. of India. Similarly, fee structure for the academic year 2027-28 will get enhanced over the fee for the academic year 2026-27, by the whole sale price index announced, for that year by Government of India.

Now, therefore, in exercise of the powers conferred by sub sections (3) read with sub-section (13) of section 6 of the said Act, the Lt. Governor of the National Capital Territory of Delhi hereby notifies, that the proposed fees for the academic year 2025-26, 2026-27 and 2027-28 recommended by the 6<sup>th</sup> State Fee Regulatory Committee, shall be implemented forthwith for pursuing courses in unaided institutions affiliated to Guru Gobind Singh Indraprastha University for the academic years 2025-26, 2026-27 and 2027-28, as specified in Annexure-I hereto.







At the time of admission, students shall be required to submit a service bond as per the following:

**Regarding introduction of compulsory service bond for All India quota and State quota Undergraduate and Postgraduate Medical students**

It is hereby informed to the respective Medical Institutions that one-year Service Bond for all India Quota and State Quota Undergraduate and Postgraduate Medical students after completion of their course (including internship period) has been introduced in the Medical institutions in Delhi. Students passing out of the Undergraduate/Post Graduate (including super-speciality courses) are mandatorily required to serve in the Medical institutions under GNCTD of Delhi for a period of one year.

The UG/PG students would be required to furnish a bond of Rs. 15 lacs (Rupees fifteen Lacs) for UG Courses and Rs. 20 lacs (Rupees twenty Lacs) for PG courses (including super-speciality courses) at the time of admission in the respective Medical College/Institution, which will stand forfeited in case the student wants to opt out of the Mandatory Service Period.
