Sub: Fraudulent and unlawful activities of an organization operating mainly under the name 'Krishi Bikas Shilp Kendra' (KBSK) with its Administrative office at Kolkata, West Bengal.

Sir/Madam,

It has come to notice that an organization operating mainly under the name, 'Krishi Bikas Shilp Kendra' (KBSK) with its Administrative office at Kolkata, West Bengal, has been falsely claiming that it has been authorized to implement the Twenty Point Programme of Govt. of India.

The Govt. of India, Ministry of Statistics & Programme Implementation has clarified that the Ministry had never authorized or associated any private organization in the implementation of Twenty Point Programme and never involved the aforesaid 'Krishi Bikas Shilp Kendra' in its activity in any manner.

The Ministry has further informed that a number of instances had been brought to the notice of the Ministry for the misuse of National Emblem and Government of India Logo by the said organization. The said organization is now seeking financial assistance in hundred of crores of rupees from various Ministry/Departments to implement Twenty Point Programme.

As the Ministry has received various other complaints against the said organization for enrolling unsuspecting persons with the promise of employing them in Government of India, the Ministry has requested the Central Bureau of Investigation to investigate and file criminal cases if required against the said 'Krishi Bikas Shilp Kendra'.

In view of the facts mentioned above all the Departments, Undertakings and Local Bodies of Govt. of NCT of Delhi are hereby informed and advised to avoid having any association with the above said organization and take necessary action if any instance of misuse on the part of the said organization is detected by the Departments.

This issues with the prior approval of Chief Secretary, Govt. of NCT of Delhi.
